OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution to Authorize the Community Development Agency Director to Temporarily Close a Section of the Existing Sienna Ridge Drive for the Re-Alignment of Sienna Ridge Drive (STA 1+03.13 To 13+50) and the Signalization Improvements During the 2013 Construction Season

WHEREAS, Serrano Associates, LLC plans to realign Sienna Ridge Drive (Old Bass Lake Road) (STA 1+03.13 To 13+50) and to construct Signalization Improvements at the intersection of Sienna Ridge Drive and Bass Lake Road, during the 2013 construction season; and

WHEREAS, a portion of existing Old Bass Lake Road will be realigned to intersect (New) Bass Lake Road and Serrano Parkway; and

WHEREAS, in order to install the approximately one thousand three hundred (1,300) linear feet of road connecting Sienna Ridge Drive (Old Bass Lake Road) with New Bass Lake Road and to complete the signalization improvements, approximately one thousand one hundred fifty (1,150) feet of Sienna Ridge Drive will need to be closed for one hundred fifty (150) calendar days; and

WHEREAS, an alternate access route will be available during the temporary closure and traffic will be directed by signage to this route; and

WHEREAS, pursuant to California Vehicle Code Section 21101 (e), the Board of Supervisors is authorized to temporarily close a portion of any street for the safety and protection of persons who are to use that portion of the street during the temporary closing; and

WHEREAS, pursuant to California Vehicle Code Section 21101 (e) and California Streets and Highways Code Section 942.6, the Board of Supervisors may delegate the powers associated with road closures to the County Road Commissioner; and

WHEREAS, the County of El Dorado Ordinance Title 12, titled Streets, Sidewalks and Public Places, Chapter 12.04 Administration, Section 12.04.030 Road Commissioner Defined, defines Road Commissioner as Director of the Department of Transportation; and

WHEREAS, Chapter 2.14 of the County of El Dorado Code of Ordinance states that any references in the code to the Community Development Director, Development Services Director, Environmental Management Director, the Director of Public Works, or the Director of Transportation shall be understood to refer to the Community Development Agency Director or his/her qualified designated representative;

NOW, THEREFORE, BE IT RESOLVED that the Community Development Agency Director is authorized to order the temporary closure of the existing Sienna Ridge Drive (Old Bass Lake Road), for one hundred fifty (150) calendar days, including weekends and holidays, in order to detour traffic and to establish an alternate access route for traffic use during the time of temporary closure. The precise dates of the temporary road closure are to be determined by the Community Development Agency Director, with notification of the pending temporary road closure and alternate route to be provided to the County Supervisors, business owners, residents, the general public, the El Dorado County Transit Authority and to safety and law enforcement agencies in the Project area, through direct communications, signage, or flyers.
