**Response:**

There were no changes in the use of the County's (includes the City of Placerville) non-disposal Facilities in 2017. El Dorado Disposal (EDD) is in the planning, engineering, and permitting phase of a complete redesign of their existing Diamond Springs Materials Recovery Facility / Transfer Station (MRF/TS) located near the City of Placerville. The existing MRF/TS will be replaced with a modern MRF/TS. Highlights of the new facility include: state of the art construction and demolition (C&D) debris processing line, expanded commercial waste processing capabilities, on-site wood waste grinding, on-site concrete crushing, additional Household Hazardous Waste (HHW) capacity, improved vehicle routing through the facility, all under roof, and a public educational center. The construction will take place in two phases. Construction of the new MRF is scheduled to begin in 2019 with a 3-year construction period with completion scheduled for 2022 depending on permitting, engineering, and the environmental review process. Deposits of lime discarded from previous industrial activities (lime kilns) must be removed prior to project completion. The project consists of four phases as follows: Phase I, schedules to begin in the fall of 2018, includes permitting of the Wetsel-Oviatt site in El Dorado Hills for C&D and green waste processing; Phase II, scheduled to begin in 2019, consists of relocating the C&D and green waste processing to the temporary Wetsel-Oviatt site and begin soil remediation of the north and west side of the Shingle Springs MRF facility; Phase III, scheduled to begin in 2020 consists of construction of the new transfer station building, scale house, recycling area and continued soil remediation (lime removal); Phase IV, scheduled to begin in 2021, consists of construction of the recycling building and completion of the soil remediation.

**Response:**

Yes. El Dorado Disposal (EDD) plans on an upgrade to their existing materials recovery facility (MRF) at their current location in Diamond Springs, California. This facility is readily used by City of Placerville residents. Construction is estimated to begin in 2019 and conclude in 2022. A temporary facility located by the Wetsel-Oviatt (former lumber mill site) in El Dorado Hills is in the planning stages and is expected to be opened in 2019 pending approval of a Conditional Use Permit to authorized processing of C&D and green waste.

<b>Jurisdiction Notes:</b> <p>The City of Placerville does not have its own Environmental Management/Health Department and refers calls received about home composting to the County Environmental Management Department (EMD). As a result of the survey and to provide education the public on home composting, EMD added a home Composting website on their website: <a href="http://www.edcgov.us/Government/EMD/SolidWaste/Home_Composting.aspx">http://www.edcgov.us/Government/EMD/SolidWaste/Home_Composting.aspx</a>. The website provides links to numerous resources for residents who would like to learn how to compost including a localized composting guide that was created by the Regional Recycling Group. The guide provides "how to" descriptions on the various types of composting, troubleshooting, and a questions and answer section. In 2017, 441 Geobin home composting systems were purchased. The composting bins were distributed to El Dorado County residents during the 2017 El Dorado County Home and Garden Show.</p> <p>The Fire Safe Council provides free on-site chipping for city and county residents. The chips are left on-site for mulch. El Dorado Disposal (EDD), in conjunction with the Master Gardeners on the Western Slope and M.O.R.E. (Motherlode Rehabilitation Enterprises) has developed a demonstration garden complete with a vermiculture (worm) bin at their Truck Street location near their MRF. This garden is used for "how to" demonstrations for community gardens, water conservation education, and backyard composting outreach. They reach out to schools providing information regarding tours, composting, and gardening. <b>Jurisdiction Notes:</b> <p>El Dorado Disposal (EDD) offers online bill pay for all customers for reduction of paper waste. EDD advertises free waste audits in their bi-annual newsletter. EDD offers free recycling to garbage service commercial accounts. EDD uses an online service, "Recollect," to provide online reminders for customers of upcoming events as well as for online calendars for various commodity pick-ups, and service day reminders, eliminating paper waste. EDD offers recycling free to commercial and MFU accounts with garbage service. EDD utilized a "pay as you throw" rate structure. Commercial and Multi-Family Units (MFU) accounts pay more for larger garbage dumpster and more frequent pick-ups. The Food Bank of El Dorado (Food Bank) has many partners with local grocery stores that donate useable food to those in need throughout local area communities. The County EMD and the Food Bank made a joint application for the Food Waste Prevention and Recovery grant offered by CalRecycle in 2017 and was awarded \$277,140 for the purchase of a refrigerated food truck, forklift, electric pallet jack, an industrial ice machine, various food storage accessories, and advertising. The Food Bank is currently negotiating with Red Hawk Casino for implementation of the Food Waste Prevention and Recovery Program once the equipment is purchased.</p>

**Jurisdiction Notes:**

The City of Placerville partners with Snowline Hospice for e-waste recycling. Resalable items are sold in Snowline Hospices' stores; other items are handled through their recycling program where equipment is dismantled and components are sold when available markets are identified. El Dorado Disposal (EDD) provided all City offices with mixed recycling collection receptacles. The mixed recycling material is consolidated at a mixed recycling bin for pick up by EDD. EDD provides free pickup of recyclable materials. City offices recycle confidential mixed paper through Shred Stop, a secure shredding company. The City surplus' furniture and office supplies for reuse by other City staff or other local government agencies and schools. Nearly all office supplies and furniture is reused. The City auctions off any un-needed surplus when available. Boxes for collection of spent batteries are also available to City staff. City grounds maintenance staff accumulates green waste that is generated by maintenance activities at City park facilities and is composted at Lions Park or Gold Bug Park. The composted material is used by facilities for their maintenance projects throughout the City.

**Jurisdiction Notes:**

There are several thrift stores and second hand stores located in the City. Snowline Hospice has a large reuse program. El Dorado Disposal (EDD) has a bin at the MRF to collect gently used items for the Partner's In Care thrift store (closed in 2017). EDD in conjunction with Cameron Park Rotary, provides for used bicycles that are pulled aside at the MRF and picked up by Rotary. The rescued bicycles are then repaired and refurbished by Folsom Prison inmates and returned to the county to various charities that distribute the bicycles to those in need. Many of the bicycles come from the City and are returned to charities benefiting local children. Resident and businesses may take useable items to local thrift stores and/or Habitat for Humanity located in El Dorado. The items are sold back to the community. Millwood Furnishings located east of Placerville and Habitat for Humanity accept useable C&D wood and furniture and resells that material back to the community. City residents and businesses are able to take their reusable C&D waste to Millwood Furnishings and Habitat for Humanity.

Placerville has mandatory garbage collection and curbside recycling (City Code Title 7, Chapter 1A, Solid Waste Regulations, and has a franchise agreement with El Dorado Disposal (EDD) for services within the City. EDD utilizes a 3 cart system using green cans with color coded lids: black lids for trash/garbage, yellow lids for recycling, and green lids for yard waste. EDD has implemented Recycle Bank in Placerville on a subscription basis as a way to encourage additional recycling. Customers in the City have either a 64 or 96 gallon recycle cart with a second recycle cart offered to residents free of charge. Recycling is picked up every other week. EDD's side-load trucks have cameras in the hopper to monitor contamination. Residential MWS is sorted at the EDD Material Recovery Facility. Residents are provided vouchers for free one-time pick-up of an appliance or a bulk waste item (items with Freon have an extra charge). Residential MWS is sorted at the EDD MRF. In addition to cart service, EDD offers one-time per year curbside pick-up vouchers per year for: 1 bulk-item, green waste. By appointment, EDD will pick-up curbside used oil/oil filters and household batteries. EDD has expanded curbside service offering bi-annual unlimited green waste collection.

Residents may drop off metal, e-waste, florescent bulbs, Styrofoam, cardboard, newspaper, ridged plastic, household batteries, and bicycles free of charge at the EDD MRF in Diamond Springs. EDD's MRF also has a program called USAgain which is a drop box available to customers for free for the collection of useable textiles and other clothing articles. There is also a recycle drop-off and buy-back center next to the MRF. The Recycle Center accepts, CRVs, cardboard, paper, plastic, metal, e-waste, household batteries, and florescent light bulbs free of charge. Residents may also bring their HHW and sharps to the MRF on Fridays, Saturdays, and Sundays for free. Residents are provided vouchers for free one time drop off of 2.5 cubic yards of debris or a bulk waste item (items containing Freon have an extra charge).

EDD offers buyback for bottles and cans at three locations in the county: In Diamond Springs adjacent to the MRF, El Dorado Hills, and Cameron Park. The City has 2 privately run buyback CRV recycling centers. El Dorado County reported 697 tons of CRV materials were collected from the west slope of the county. Based on population data, the residents in the City of Placerville account for 7% of the population; therefore, a rough estimate provides that approximately 48.79 tons of the CRV materials that were recycled at a buyback center were from the City of Placerville.

EDD provides recycling service to every public school and most private schools regardless of size, free of charge. All schools within the City of Placerville are taking advantage of this free program. The schools have significantly reduce their cost of service. EDD has met with the superintendents, principals, teachers, and janitors. EDD has provided blue cubes for use in the class rooms for ease of use for recycling. EDD has staff members trained to assist the schools with class room curriculum and arrange for tours of the MRF at a time convenient to the individual classroom. EDD also participates in "Ag Day," focused on elementary school-age children. At this event children are introduced to composting and vermiculture. EDD mails information about their free education and recycling program to each school. The program includes tours of EDD's MRF and their composting / reuse garden. In 2017, EDD conducted X MRF tours, X truck tours, and X school presentations on waste processing, recycling, and composting.

Phone calls were conducted by EDD to business or multifamily complexes after assessing the amount of organic material in the dumpster; emails were sent the commercial businesses; summer and winter newsletters were published in the local newspaper; and the EDD website was updated in 2017 with AB 1826 information.

EDD reported difficulties in assessing customer's bins in relation to the threshold requirements. EDD suggests changing the threshold to 4 cubic yards of the total MSW/week to match the AB 341 threshold requirements. It has also been reported that customer's are having difficulty in locating space for an additional (third) bin when existing dumpster facilities have been designed for only one or two dumpsters.

EDD is in the planning and permitting phase of constructing a new modern TS/MRF which is located in Diamond Springs which is outside the City of Placerville. The franchise agreement El Dorado County has with El Dorado Disposal states that EDD will build a new MRF within 5 years of the new agreement. EDD and EMD are evaluating whether organics processing technology can be included in the design for the new MRF. There are size limitations so in vessel composting system is being considered. This technology is also being considering for the County's Union Mine Landfill.

Please describe any efforts underway to develop new private or public regional organic waste recycling facilities, the anticipated timeline for completion, the types of feedstocks these facilities may accept, and the potential available organic material capacity at those facilities for your county or regional agency's organic waste, including food.**

The County EMD has met with its franchise waste haulers EDD regarding new organics diversion technologies and are evaluating the possibility of siting an on-site in-vessel composting, or other technology, at their MRF located in Diamond Springs. El Dorado County, including the City of Placerville, was also recently approved as a new Recycling Market Development Zone (RMDZ). RMDZs are able to offer low interest loans, siting and permitting assistance, and other incentives to existing or new businesses that manufacture products out of discarded materials. New or expanded organics processing activities are eligible for RMDZ benefits and EMD anticipates that these incentives will encourage organics processing businesses to consider El Dorado County.

EMD has a Home Composting web page containing information about home composting and links to composting resources. EMD staff has collaborated with the UCCE Master Gardener Program to promote home composting. EMD staff promoted home composting at the 2017 EDC Home and Garden Show and the 2017 El Dorado County Fair. Home composting bins are provided free to County and City residents who pledge to try home composting. EDD has a home composting and vermiculture demonstration project at its Truck Street facility in Diamond Springs.

**8. Please describe the jurisdiction's efforts to reduce food waste at the source and increase edible food recovery (e.g. promoting source reduction, expanding food donation, incentivizing partnerships with local food recovery organizations, changes in local government and school programs to reduce and/or donate surplus edible food).**

The Food Bank of El Dorado has a robust food recovery program that reaches all areas of El Dorado County. EMD partnered with the Food Bank of El Dorado and has received a Food Waste Prevention and Rescue Grant FY 16/17 in the amount of \$277,140 for the purchase of a refrigerated truck, a forklift, an electric pallet jack, food storage boxes, and for advertising to promote and expand food waste rescue and prevention in the County.

**9. Describe local zoning codes that allow organic waste processing facilities and local permit requirements for siting a new organic waste recycling facility within the jurisdiction.**

Zoning options for organics processing facilities in the City of Placerville include:

Heavy Commercial which could permit a processing facility for recyclable materials with approval of a Conditional Use Permit; and in Industrial which could permit a processing facility for recyclable materials with approval of a Conditional Use Permit. As a discretionary permit, a Conditional Use Permit application would be subject to environmental review in accordance with CEQA. "Pre-zoned" Industrial properties are only located in the Smith Flat area outside of the Placerville City limits within the City's Sphere of Influence requiring annexation into the City for development.

**10. Please describe any local incentives available for developing new organic waste recycling facilities within the jurisdiction (e.g. economic incentives, workforce training, permit fee waivers etc.)**

El Dorado County, including the City of Placerville, was also recently approved as a new Recycling Market Development Zone (RMDZ). RMDZs are able to offer low interest loans, siting and permitting assistance, and other incentives to existing or new businesses that manufacture products out of discarded materials. New or expanded organics processing activities are eligible for RMDZ benefits and we hope that these incentives will encourage organics processing businesses to consider siting in El Dorado County.

The City has adopted a Environmentally Preferable Purchasing Policy which focuses on recycled content paper and paper products and includes the preference for purchase and use of recycled content products including compost, mulch, and other organics.

Waste haulers are evaluating options for rate adjustments to cover costs associated with implementation of AB 1826.

Due to a low density of population and decentralized development pattern existing within El Dorado County and a low volume waste stream together creates an impediment to developing new organic waste recycling facilities locally with no economies of scale making a commercial operation financially infeasible.

The City enlarged the east garbage bin enclosure within the parking garage to accommodate an additional bin for the collection of organic waste.
