WHEREAS, the County of El Dorado has received an application from Catherine M. Huffman, an unmarried woman Richard J. Anderson, an unmarried man, as joint tenants owner of Parcel A requesting that the County of El Dorado vacate the 25' Drainage Easement of said property, identified as Assessor's Parcel Number 048-240-031; and

WHEREAS, Department of Transportation, AT&T, Comcast, El Dorado Irrigation District and Pacific Gas & Electric as well as all other parties holding record title interest have not used said portion of subject easement for the purposes for which it was dedicated and find no present or future need exists for said portion of subject easement and does not object to its vacation, and to that end, have all issued letters to that effect; and

WHEREAS, the Surveyor's Office has determined that said portion of subject easement has not been used for the purpose for which it was dedicated and has no objection to its abandonment and wherein Exhibit A describes the easement to be abandoned and is depicted on Exhibit B; and

WHEREAS, all other existing easements shall remain.

NOW, THEREFORE, BE IT RESOLVED, that from and after the date this Resolution is recorded, said offer for said portion of subject easement is terminated and abandoned and no longer constitutes an offer for easement. 
