### ORDINANCE NO. 5264

THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS: RELATED TO REZONING IN THE PLACERVILLE AREA:

Section 1. The Official Zoning Map is hereby amended to rezone the following described lands, as shown in Exhibit A:

The parcel is hereby amended:

From: Five-Acre Residential Estate (RE-5)

To: One-Acre Residential (R1A);
