**RESOLUTION NO. 028-2010**

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO ADOPTING A BASE FEE OF \$10.00 AS THE FEE PROVIDED BY AB 676 AMENDING GOVERNMENT CODE 27361(a) FOR THE RECORDING AND INDEXING OF EVERY INSTRUMENT, PAPER, OR NOTICE REQUIRED OR PERMITTED BY LAW TO BE RECORDED; ALSO, TO ADOPT THE FEE PERMITTED BY GOVERNMENT CODE 27361.2 AS \$3.00 FOR EACH REFERENCE AFTER ONE REFERENCE ON EVERY INSTRUMENT, PAPER, OR NOTICE REQUIRED OR PERMITTED BY LAW TO BE RECORDED AND, TO ADOPT THE FEE PERMITTED BY GOVERNMENT CODE 27361.8 AS \$5.00 FOR EACH GROUP OF 10 NAMES AFTER THE FIRST GROUP OF 10 NAMES ON EACH INSTRUMENT, PAPER, OR NOTICE REQUIRED OR PERMITTED BY LAW TO BE RECORDED AND,**

**WHEREAS,** the base fee for recording the first page of a document was established in 1972 as \$3.00 and,

**WHEREAS,** the only change to this fee was in 1984 with the addition of \$1.00 to support, maintain, improve, and provide for the full operation for modernized creation, retention, and retrieval of information in each county's system of recorded documents and,

**WHEREAS,** the Board of Supervisors has been provided the authority to increase recording fees pursuant to Sections 27361(a), 27361.2 and 27361.8 of the Government Code; to reimburse the county for the actual costs of services rendered.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** that the El Dorado County Board of Supervisors approves effective thirty (30) days after approval; that the base fee for the recording of the first page of each instrument, paper, or notice required or permitted by law to be recorded shall be \$10.00 and,

**BE IT FURTHER RESOLVED AND ORDERED** that the El Dorado County Board of Supervisors approves effective thirty (30) days after approval; that the fee for indexing each reference after the first reference on each instrument, paper, or notice required or permitted by law to be recorded shall be \$3.00 and,

**BE IT FURTHER RESOLVED AND ORDERED** that the El Dorado County Board of Supervisors approves effective thirty (30) days after approval; that the fee for indexing each group of 10 names or portion of a group of 10 names after the first 10 names on each instrument, paper, or notice required or permitted by law to be recorded shall be \$5.00.
