Original bid was for 11 acres at \$850/Acre; Change Order 009 increased total by 5 acres to 16 acres; Amendment 1 to Change Order 009 increased the bid item by another 12 acres for a total of 28 acres; however, the first amendment to Change Order 009 was ultimately unnecessary as the cost of the additional work was paid on a time and materials basis due to the differing scope of work associated with clearing and grubbing additional acreage containing mature trees. The work associated with this Change Order has been completed and the contractor has been paid in full. The contractor waives any claims for additional time or payment for the matters related to this Change Order.
