

AGREEMENT FOR SERVICES #3132
AMENDMENT II

This Amendment II to that Agreement for Services #3132 is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Nelson S. Jacinto, doing business as Grace Home II, duly qualified to conduct business in the State of California, whose principal place of business and licensed Residential Care Facility for the Elderly (RCFE) is located at 9260 Loma Lane, Orangevale, CA 95662; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide long-term, twenty-four (24) hour program and facilities for mentally ill adults, in accordance with Agreement for Services #3132, dated August 14, 2018, and Amendment I, dated October 9, 2018, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend Article IV, "Maximum Obligation," and Article XXV, "Administrator" of said Agreement; and

WHEREAS, the parties hereto have mutually agreed to add Article XXXII, "Counterparts" of said Agreement.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #3132 shall be amended a second time as follows:

1) **ARTICLE IV** shall be amended in its entirety to read as follows, and shall be effective upon final execution of this Amendment II:

ARTICLE IV:

Maximum Obligation: The maximum contractual obligation under this Agreement shall not exceed \$290,000 for services provided during the term of this Agreement.

2) **ARTICLE XXV** shall be amended in its entirety to read as follows, and shall be effective upon final execution of this Amendment II:

ARTICLE XXV:

Administrator: The County Officer or employee with responsibility for administering this Agreement is Nicole Cable, LMFT, Manager of Mental Health Programs, Behavioral Health Division, or successor.

3) **ARTICLE XXXII** shall be added in its entirety to read as follows:

ARTICLE XXXII:

Counterparts: This Agreement may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Agreement and all of which, when taken together, will be deemed to constitute one and the same agreement

Except as herein amended, all other parts and sections of that Agreement #3132 shall remain unchanged and in full force and effect.
