

AGREEMENT FOR SERVICES #437-S1211 (#832)
AMENDMENT II

This Amendment II to that Agreement for Services #437-S1211 (#832), made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and TracNet Corporation, a California corporation, duly qualified to conduct business in the State of California, whose principal place of business is 1277 Adobe Lane, Pacific Grove, CA 93950; (hereinafter referred to as "Consultant");

RECITALS

WHEREAS, County has entered into a separate perpetual Software Product License Agreement with Consultant identified as Agreement #714-S0811 dated March 25, 2008 and subsequent amendments (hereinafter "License Agreement") for certain programs and services relating to automated criminal information and additional law enforcement/public safety operations and management; and

WHEREAS, Consultant has been engaged by County for a Software Maintenance Service Plan, in accordance with Agreement for Services #437-S1211 (#832), dated May 22, 2012 (hereinafter "Maintenance Agreement"); and

WHEREAS, the parties hereto have mutually agreed to amend the Agreement to add a new service to be performed by Consultant; and

WHEREAS, the parties hereto have mutually agreed to amend the Not to Exceed Amount in Article III to match the Revised Exhibit A, incorporated into Amendment I executed June 30, 2017.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #437-S121 (#832) shall be amended a second time as follows:

1. The scope of work of the Maintenance Agreement is revised to add the following service: TracNet will build and provide an updated interface to KEEFE. Every 15 minutes the interface will push real time inmate information to KEEFE's servers allowing KEEFE to keep the Inmate Trust Accounts current. The cost of this service is included in the total not to exceed amount of the agreement.
2. The last sentence of **ARTICLE III** is hereby amended to read as follows:

The total amount of this Agreement shall not exceed \$1,345,957.63 inclusive of all costs and expenses.

Except as herein amended, all other parts and sections of that Agreement #437-S1211 (#832) shall remain unchanged and in full force and effect. All provisions, attachments and upgrades of the Maintenance and License Agreements, previously attached, remain unchanged and in full force and effect.
