



RESOLUTION NO. 123-2018

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the County of El Dorado Board of Supervisors is authorized to adopt new fees, fee levels, and charges, pursuant to Government Code § 54985; and

WHEREAS, the County of El Dorado's Health and Human Services Agency has reviewed and analyzed the current Emergency Medical Services Agency fee structure; and

WHEREAS, the County completed said analysis, which included a review of the Emergency Medical Services Agency operations (personnel, indirect and overhead, supervision and equipment costs), and a full cost recovery analysis as well as comparison against prevailing fees charged in surrounding counties, as applicable;

WHEREAS, all current fees were found to be appropriate, and clarification of frequency was added to current fee descriptions in relation to services that are subject to renewal fees; and

WHEREAS, five (5) new fees were added to the current fee schedule;

NOW, THEREFORE, BE IT RESOLVED that effective July 17, 2018, this Resolution, and the fees, fee levels, and charges attached hereto as Exhibit A, "Emergency Medical Services (EMS) Agency Fees" shall be implemented, and supersede any prior written or verbal Emergency Medical Services fees specific to Exhibit A, hereto.
