EL DORADO COUNTY PC-20160346 Petition for Writ of Mandate and Declaratory Relief" ("Decision"),

THE COUNTY OF EL DORADO AND EL DORADO COUNTY BOARD OF SUPERVISORS ("COUNTY") ARE HEREBY COMMANDED AND ORDERED to comply with the following:

PEREMPTORY WRIT OF MANDATE

- 1. Within 60 days from service of this writ of mandate, the County of El Dorado and El Dorado County Board of Supervisors shall strike the text of the Measure E amendments to Policies TC-Xa 3, TC-Xa 4, TC-Xa 6, and TC-Xf from the 2004 El Dorado County General Plan. The County shall restore those policies to the language in effect immediately prior to the July 29, 2016 effective date of Measure E.
- 2. The County of El Dorado and El Dorado County Board of Supervisors shall add the text of Implementation Statements 1, 3, 4, 5, 6, and 7 to the Transportation and Circulation Element of the General Plan.
- 3. The County of El Dorado and El Dorado County Board of Supervisors shall file a return to the peremptory writ of mandate within 80 days of service of this Peremptory Writ. The Court shall retain jurisdiction over this lawsuit by way of the return of the peremptory writ of mandate until the Court has determined that the County of El Dorado and El Dorado County Board of Supervisors has complied with the terms of the peremptory writ of mandate consistent with this court's ruling.
