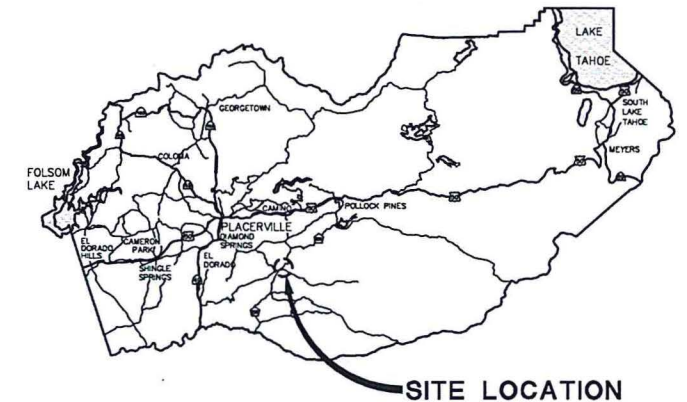

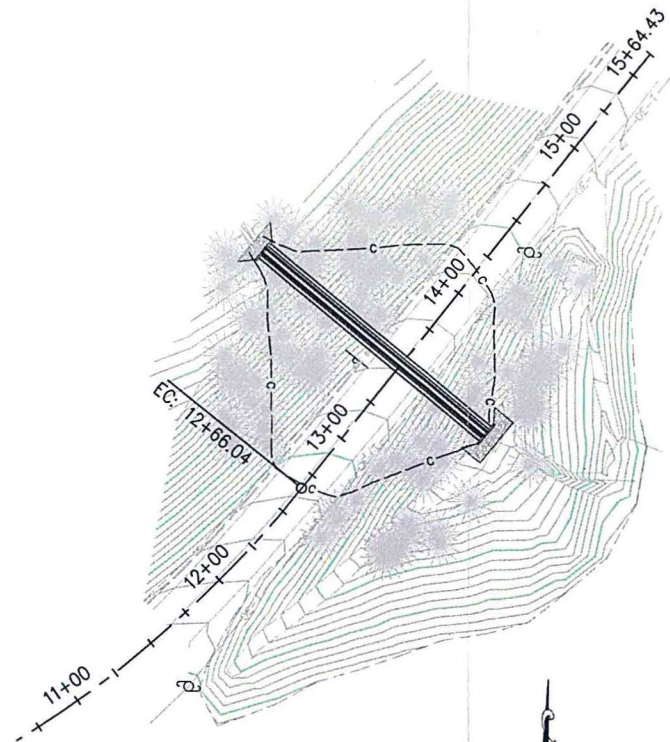

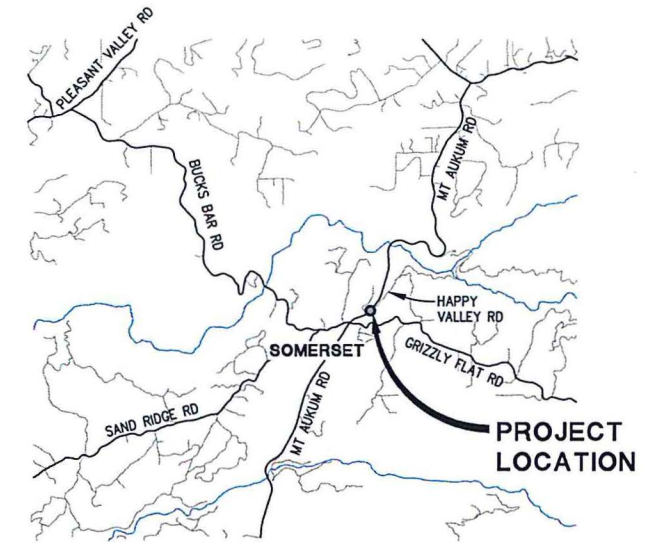


SITE LOCATION
