Resolution for Road Closure for
“5K Walk/Run for Hunger”

WHEREAS, The Food Bank of El Dorado County (sponsor) desires to hold the “5K Walk/Run for Hunger” charity event on Saturday, October 23, 2010, from 5:00 a.m. to 10:00 a.m., sanctioning road closures in the El Dorado Hills Business Park of Windfield Way (between White Rock Road and Golden Foothill Parkway); Windplay Drive (between Windfield Way and Suncastr Lane); Suncastr Lane (between Windplay Drive and Latrobe Road/Gate 2); Golden Foothills Parkway (between Latrobe Road/Gate 1 and Robert J. Matthews Parkway); Sandstone Drive (at Golden Foothill Parkway); Hawks Flight Court (at Golden Foothill Parkway); Sunglow Court (at Suncastr Lane) and Cypress Point Court (at Golden Foothill Parkway) in El Dorado Hills, El Dorado County, and;

WHEREAS, said sponsors have applied for a Road Closure Permit pursuant to Vehicle Code 21102(e), Ordinance Code §12.37.010 et seq., and County Resolution 110-79 in order to promote the “5K Walk/Run for Hunger” on Saturday, October 23, 2010; and;

NOW THEREFORE BE IT RESOLVED that a road closure will be in effect in the El Dorado Hills Business Park from 5:00 a.m. until 10:00 a.m. on Saturday, October 23, 2010, subject to the conditions set forth in Resolution No. 110-79 dated May 1, 1979, and subject to the conditions set forth in the Application for Road Closure submitted for this event.

This Resolution and the Application with conditions shall together constitute the Road Closure Permit.
