- Generates approximately \$1.5 Million annually to El Dorado County
- Funds projects for families with young children from birth through age five through a five-year strategic plan

- Since 2001, First 5 has invested over \$12 Million to various programs in El Dorado
- In 2009-10, \$1.1 Million allocated to support Commission and Community Initiatives
- Strategic Plan allocates over \$3 Million in funding over the next three years, 2010-2013

- Strengthen Commission Initiatives with enhanced services
- Implement the Dental Van
- Release \$200,000 for community based projects beginning in July 2010
- Identify and address the family support and education needs of families with young children through a Commission Initiative

Next Steps



Governor's 2010 Budget Proposal will:

- Eliminate First 5 California Commission
- Eliminate the Healthy Kids/Healthy Futures Initiative
- Cut First 5 El Dorado's allocation by 50% for 5 years resulting in:
 - reduced services to families with young children
 - loss of infrastructure to the county reserve fund
 - loss of funding for small community-based organizations in South Lake Tahoe, Georgetown Divide and Western Slope
 - Eventual loss of programs and jobs within the county including EDC office of education, EDC library programs and EDC health services
