FIRST AMENDMENT TO AGREEMENT FOR SERVICES #3802

THIS FIRST AMENDMENT to that Agreement for Services #3802 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Dudek, a corporation duly qualified to conduct business in the State of California, whose principal place of business is 605 Third Street, Encinitas, California 92024, and whose local office address is 1102 R Street, Sacramento, California 95811 (hereinafter referred to as "Consultant");

RECITALS

WHEREAS, County has determined that it is necessary to obtain a consultant to assist its Planning and Building Department, in planning services on an as-needed basis, pursuant to Agreement for Services #3802, dated June 25, 2019, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date for three (3) additional years, to June 24, 2025, amending **ARTICLE II, Term**;

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$250,000, for a total not-to-exceed amount of \$400,000, amending **ARTICLE III, Compensation for Services**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

I. **ARTICLE II, Term**, of the Agreement is amended in its entirety to read as follows:

This agreement shall become effective upon final execution by both parties hereto and shall expire June 24, 2025.

II. **ARTICLE III, Compensation**, the sixth paragraph of the Article is amended in its entirety to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$400,000, inclusive of all Task Orders and/or Work Orders, costs, taxes, and expenses.

Except as herein amended, all other parts and sections of Agreement for Services #3802, shall remain unchanged and in full force and effect.
