Greetings to the Board!

Regarding agenda item 21-1039 for the June 29, 2021 meeting, I want to express to you my firm disagreement and plead with you to deny this resolution. As an EDH resident with 9 and 11 year old kids, I want the highest safety for our schools with authority placed in public health officials hands.

We have done our part as a family to keep ourselves safe from covid and to not endanger more vulnerable people. My husband and I have gotten vaccinated as soon as we were eligible but my kids are not yet eligible.

The idea that another family's choice can threaten my kids and potentially bring a virus that we've worked very hard to avoid for 15 months is just appalling to me. I have so appreciated the protection provided to us by public health requirements. Therefore I would be greatly upset if authority were transferred to the schools before my kids are even eligible for vaccines. I don't trust people enough to have confidence that we would not be exposed. We know too many people who do not take covid seriously and we know the risks that they pose on others.

The last school year was a success with low spread in schools because we had mitigation measures in place such as masking and distancing. We've already minimized distancing, and now we are considering elimination of masking. Removal of mitigation measures only makes us less safe and so it is an unwise, unsafe idea!

Masks are tolerable. Kids can handle wearing them. They often leave school and walk all the way home with their masks still on because they barely notice them.

So many of the points in the resolution are easy to debunk and the whole concept is simply not fair to families like ours. I plead with the board to deny the resolution.

At the bare minimum, please postpone such a change until kids under 12 are able to be fully vaccinated which may not be until 2022. Or, prioritize the choice of careful families like mine and mandate schools to have masked classes where we can trust that our kids aren't exposed to unmasked kids who might expose them to a disease that we have worked so hard to avoid.

This comment is in regards to Item 21-1048 on the June 29th, 2021 Board of Supervisors Agenda.

Dear EDC Board of Supervisors:

I am writing in my role as the Chair of the Georgetown Divide Fire Safe Council to urge you to support the El Dorado County Resource Conservation District and the Georgetown Divide Resource Conservation District to the maximum extent possible. I will give you just one example from my own experience as to why the RCD is a great investment for El Dorado County.

The Georgetown Divide Fire Safe Council applied for and received a grant from the California Fire Safe Council in 2019 to treat 3.5 miles of Shoo Fly Road in Kelsey within the county right-of-way, up to 40 feet on either side of the road. The goal was to create a shaded fuel break to allow residents of Shoo Fly Road to safely evacuate in case of emergency, to create a break to help stop the forward progress of a fire, and to create safe anchor points for firefighting personnel to fight a fire. Ideally the County DOT would be the ones clearing this road, but with the lack of county funding for such purposes, we applied for a grant to do the work. Which we received. That was the easy part. Then we had to implement the project! I am a volunteer with no professional background in managing fuel reduction projects, so thankfully, Mark Egbert and the Resource Conservation District team were available to manage the project for us and make sure it got done on time, within the allotted grant amount and treatment goals, and meeting all environmental requirements along the way. I have learned throughout this process that seemingly simple projects like roadside treatments are extremely complex to manage, particularly in most parts of El Dorado County where you have multiple private landowners along with government landowners (in our case, USFS and BLM) that need to be engaged and coordinated, and that all have different requirements. We could not have managed this project on our own.

Fast forward to the summer of 2021, and we are finishing up this project as of June 30, 2021. With the help of RCD and pro bono work from the California Conservation Corps, we were able to expand the treatment area beyond the original grant scope to include Spanish Flat Road, an important evacuation route not only for residents of Shoo Fly Road, but many more residents in Kelsey that live east of 193. And the treatment on Shoo Fly Road was completed just in time! On June 4, 2021, a fire that ignited near Shoo Fly and Hwy 193 was spotted by a volunteer in the Pilot Hill look-out tower. CalFire was able to quickly contain the fire at 0.17 acres, and credited the just-completed Shoo Fly roadside treatment with their ability to quickly and effectively contain the blaze at such minimal acreage.

As you can see from this one example, an investment in RCD is multiplied many times over. RCD is assisting ordinary people in our community that are volunteering with the Fire Safe Councils to obtain funding for and implement fuel reduction projects in their communities. These are projects that the county is otherwise not able to do for whatever reason. And, the projects that RCD is stewarding save money by helping to prevent and/or contain fires before they become large wildfires that destroy whole communities. As I am sure you would agree, prevention is always preferable to disaster recovery. And cheaper.

Thank you supporting the Resource Conservation District.

The existing scientific evidences challenge the safety and efficacy of wearing facemask as preventive intervention for COVID-19. The data suggest that both medical and non-medical facemasks are ineffective to block human-to-human transmission of viral and infectious disease such SARS-CoV-2 and COVID-19, supporting against the usage of facemasks. Wearing facemasks has been demonstrated to have substantial adverse physiological and psychological effects. These include hypoxia, hypercapnia, shortness of breath, increased acidity and toxicity, activation of fear and stress response, rise in stress hormones, immunosuppression, fatigue, headaches, decline in cognitive performance, predisposition for viral and infectious illnesses, chronic stress, anxiety and depression. Long-term consequences of wearing facemask can cause health deterioration, developing and progression of chronic diseases and premature death. Sylvia:

Masks are really for infected people to prevent them from spreading infection to people who are not infected rather than protecting uninfected people from acquiring infection. The typical mask you buy in the drug store is not really effective in keeping out virus, which is small enough to pass through the material. It might, however, provide some slight benefit in keep out gross droplets if someone coughs or sneezes on you. I do not recommend that you wear a mask, particularly since you are going to a vey low risk location. Your instincts are correct, money is best spent on medical countermeasures such as diagnostics and vaccines.





Regarding Item 41, the masks in the schools resolution.

This goes way beyond your scope of expertise and sets an ill advised precedent if you act on this item.

First, this is a school board decision, not yours to make.

Second, you are not medically trained and should not be making medical decisions. Dr Nancy Williams is employed to provide medical guidance; heed her words.

I am writing to strongly encourage you to approve the Healthy Children Resolution. The County should not support implementing the state "Guidance" related to schools, specifically the wearing of masks by students, teachers and administrators, forced six-foot separation and the not sharing of instructional materials, games. etc.

Here are the reasons why school districts should open "normally" this fall, with no masks, nor forced distancing, no plexiglass dividers, etc:

1. **These are Guidelines** only and not enforceable by law. There is no legal statute that enforces these guidelines.

2. "Guidance" means recommended actions. **There are no legal penalties** for not following these guidelines.

3. Each district and school has the **authority to implement the guidelines according to their own needs**: "Implementation of this guidance should be tailored for each setting... including the needs of students and families." "School leader should engage...families, stadd and labor partners... to formulate and implement plans."

4. The guidelines include a link to CAL/OSHA regulations, which state: "**Cloth face covers are not protective equipment and do not protect the person wearing a cover against COVID-19.**"

5. The guidelines also include a link to the CDC, **which offers no reputable medical or scientific evidence that supports the use of masks outside of a medical setting.**

6. The California Board of Health states that "**wearing masks could INCREASE RISK OF INFECTION**"

7. The New England Journal of Medicine states that, "Outside of a medical setting, **the wearing of masks provides little, if any, protection against the transmission of disease.**"

8. **There are countless documented physical, mental and emotional harms associated with wearing masks.**

9. **There is no special liability** associated with a person catching a communicable disease at a workplace. In fact, it is the opposite: it is much harder to prove because you (a) have to prove that a person KNEW he was infected and (b) That person had to WILLFULLY intend to infect another person. (see references, point 11: Infectious diseases)

10. **Your workplace is MORE likely to be sued** because of the health harms of wearing a mask by both the teachers and the students, including: (a) reduction in oxygen (must have 19.5% oxygen in the atmosphere according to OSHA regulations; masking can result in 18.5% or below, putting the wearer at "Immediate Danger to Life and Health", with "irreversible adverse effects" --- according to OSHA regulations; (b) students or teacher passing out due to carbon dioxide toxicity. and possibly falling, hitting their head and dying.

11. **Instructional impediments to learning:** face masks are threatening, menacing, divisive; they impede normal social interaction; language is garbled; a barrier between student and teacher is created.

12. **There is no sound, scientific or medical evidence supporting "social distancing"** or any other onerous recommendations (these are not laws, nor are they enforceable by law) such as no sharing of instruction materials or games, etc. There is ZERO science between having students sit in desks 6 feet apart. It is the opposite: the division is harmful on a physical, psychological, emotional and instructional level.

I have some serious concerns about the proposed resolution.

The first concern is that the Board of Supervisors will provide a resolution that gives public health recommendations without the Board having the expertise to make public health guidelines. As a Medical Doctor, I recommend that the Board takes information from the pertinent organizations that will reflect the current situation and status reflective of El Dorado County. Rather than using a few statistics and data from the World Health Organization which does not even reflect the current recommendations from the organization, I would recommend the Board look at the recommendations and guidelines from the US Dept of Health and Human Services, the California Dept of Public Health, and specifically the guided information provided from the El Dorado County Dept of Public Health. The latter can make guidelines and recommendations for the County. As a County Board, you can then decide whether you want to follow these recommendations or not. That procedural pathway is in stark contrast to the Board of Supervisors creating its own guidelines without the prerequisite expertise or authority to create Public Health recommendations.

The second concern is about jurisdictional authority. The County Board of Supervisors is making a resolution for School Districts when the duly elected authority to do so is the El Dorado County Board of Education. This resolution relinquishes the County Board of Education to be in control of their jurisdiction. As a Special District Commissioner on LAFCO, this presents a problem when the County is taking away the authority from the duly elected officials to make these decisions. For the Supervisors that are also Commissioners on LAFCO, please be aware of what this resolution does and if passed will require me to have discussions with the Board of Education and elevate this to the attention of LAFCO.

Any attempt to restrict the content of such speech must be narrowly tailored to effectuate a compelling state interest. Specifically, the courts found that policies that prohibited members of the public from criticizing school district employees were unconstitutional. (*Leventhal v. Vista Unified School Dist.* (1997) 973 F. Supp. 951; *Baca v. Moreno Valley Unified School Dist.* (1996) 936 F. Supp. 719.) These decisions found that prohibiting critical comments was a form of viewpoint discrimination and that such a prohibition promoted discussion artificially geared toward praising (and maintaining) the status quo, thereby foreclosing meaningful public dialog.

This audience needs to know that the Clerk of the Board, or whomever is running audio, is muting/censoring the applause which is a clear violation of the public's rights. When you violate the public's rights, it is a good indicator that you had no intention of abiding by your Constitutional oaths of office.

I encourage all those in the audience, whether it be in person or on Zoom, who have prepared comments to hand them into the Clerk of the Board to enter into the permanent public record. Don't forget, you are public servants and you work for us!

# CALIFORNIA BROWN ACT

## PREAMBLE:

"The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people do not yield their sovereignty to the bodies that serve them. The people insist on remaining informed to retain control over the legislative bodies they have created."

## CHAPTER V.

### RIGHTS OF THE PUBLIC

§54954.3 Public's right to testify at meetings. (c) The legislative body of a local agency shall not prohibit public criticism of the policies, procedures, programs, or services of the agency, or of the acts or omissions of the legislative body. Nothing in this subdivision shall confer any privilege or protection for expression beyond that otherwise provided by law. Care must be given to avoid violating the speech rights of speakers by suppressing opinions relevant to the business of the body.

As such, members of the public have broad constitutional rights to comment on any subject relating to the business of the governmental body. Any attempt to restrict the content of such speech must be narrowly tailored to effectuate a compelling state interest. Specifically, the courts found that policies that prohibited members of the public from criticizing school district employees were unconstitutional. (*Leventhal v. Vista Unified School Dist.* (1997) 973 F. Supp. 951; *Baca v. Moreno Valley Unified School Dist.* (1996) 936 F. Supp. 719.) 54954.2 E (3) No action or discussion shall be undertaken on any item not appearing on the posted agenda, except that members of a legislative body or its staff may briefly respond to statements made or questions posed by persons exercising their public testimony rights under Section 54954.3.

Where a member of the public raises an issue which has not yet come before the legislative body, the item may be briefly discussed but no action may be taken at that meeting. The purpose of the discussion is to permit a member of the public to raise an issue or problem with the legislative body or to permit the legislative body to provide information to the public, provide direction to its staff, or schedule the matter for a future meeting. (§ 54954.2(a).)



Gainesville, FL (June 16, 2021) – A group of parents in Gainesville, FL, concerned about potential harms from masks, submitted six face masks to a lab for analysis. The resulting report found that five masks were contaminated with bacteria, parasites, and fungi, including three with dangerous pathogenic and pneumonia-causing bacteria. No viruses were detected on the masks, although the test is capable of detecting viruses.

- Neisseria meningitidis (meningitis, sepsis)

Half of the masks were contaminated with one or more strains of pneumonia-causing bacteria. One-third were contaminated with one or more strains of meningitis-causing bacteria. One-third were contaminated with dangerous, antibiotic-resistant bacterial pathogens. In addition, less dangerous pathogens were identified, including pathogens that can cause fever, ulcers, acne, yeast infections, strep throat, periodontal disease, Rocky Mountain Spotted Fever, and more.

The face masks studied were new or freshly-laundered before wearing and had been worn for 5 to 8 hours, most during in-person schooling by children aged 6 through 11. One was worn by an adult. A t-shirt worn by one of the children at school and unworn masks were tested as controls. No pathogens were found on the controls. Proteins found on the t-shirt, for example, are not pathogenic to humans and are commonly found in hair, skin, and soil.

A parent who participated in the study, Ms. Amanda Donoho, commented that this small sample points to a need for more research: "We need to know what we are putting on the faces of our children each day. Masks provide a warm, moist environment for bacteria to grow."

These local parents contracted with the lab because they were concerned about the potential of contaminants on masks that their children were forced to wear all day at school, taking them on and off, setting them on various surfaces, wearing them in the bathroom, etc. This prompted them to send the masks to the University of Florida's Mass Spectrometry Research and Education Center for analysis.



## **Resolution on Mask Choice**

**WHEREAS**, the World Health Organization (“WHO”) and UNICEF both state that children 5 years and under should not be required to wear masks, and advise that decisions whether to impose a mask requirement upon children ages 6–11 should be made based on several factors, including the impact of wearing a mask on a child’s psychosocial development <sup>1,2</sup>; and

**WHEREAS**, the WHO also recommends against children wearing masks during exercise or play, as it accurately recognizes that masks can be harmful because they compromise a child’s ability to breathe; and

**WHEREAS**, recent studies have shown that repeated exposure to mask wearing over longer periods can be extremely harmful <sup>3</sup>; and

**WHEREAS**, numerous studies have shown that children are less likely to transmit and less likely to get symptomatic COVID-19 than adults <sup>4,5,6,7,8,9</sup>; and

**WHEREAS**, children do not typically spread COVID-19, even without wearing masks <sup>10</sup> and teachers are no more likely to be hospitalized due to Covid-19 than in other occupations <sup>11</sup>; and

**WHEREAS**, the ability to see, appreciate and communicate through facial expressions is crucial to a child’s social development <sup>12</sup>, mental health <sup>13</sup>, physical well-being <sup>14</sup>; and

**WHEREAS**, compared with 2019, the proportion of mental health reported by the United States Centers for Disease Control beginning in April 2020–related visits for children aged 5–11 and 12–17 years increased approximately 24%. and 31%, respectively <sup>15</sup>; and

**WHEREAS**, it is repeatedly stated in multiple places, including various scientific studies, as well as on the box of medical masks, that masks are not effective at preventing the spread of Covid-19; and

**WHEREAS**, in El Dorado County, persons 0–17 years old account for ZERO total deaths due to Covid-19, and only 12% of all Covid-19 cases; and

**WHEREAS**, schools in El Dorado County have had zero Covid-19 transmission occurring on campus; and



**WHEREAS**, the majority of adults and children over 12 years old—including those at high risk of adverse outcomes from COVID-19— have had ample opportunity to get vaccinated; and

**WHEREAS**, mask wearing also disproportionately impacts children who are attempting to learn English as a second language, as it impedes their ability to process their non-native language<sup>16</sup>; and

**WHEREAS**, many highly credentialed, well-respected medical professionals have recently and publicly advocated for the universal elimination of mask mandates for children.<sup>17</sup>

**NOW, THEREFORE BE IT RESOLVED**, that the El Dorado County Board of Supervisors (EDCBOS) establishes the following goals:

- Assist in the return of governing power for school safety protocols to the School Districts themselves
- Advocate for Parental Choice for masking and vaccinating their children
- Work toward removal of El Dorado County State of Emergency status
- Ensure that mask guidelines will NOT be based on vaccination status

**BE IT FURTHER RESOLVED**, that EDCBOS will seek out the assistance of any and all government agencies involved in the decisions regarding safety protocols in the school, specifically requesting assistance to make masks optional and relinquishing safety protocol decision making power to the school district itself; and

**BE IT FURTHER RESOLVED**, that EDCBOS will send a written request to CDPH requesting them to revise its guidance to eliminate any mask mandate for children in all settings throughout the state of California (at a minimum in El Dorado County), including in the classroom, at summer camp and while participating in youth sports and/or exercise ; and

**BE IT FURTHER RESOLVED**, that the EDCBOS directs the clerk to transmit official copies of this resolution to the following: superintendents for all school districts within El Dorado County, EDC Department of Public Health, California Congressmembers, California Governor, Cal Osha, California Department of Public Health, and any other entities the board deems appropriate for this resolution.
