The County of El Dorado Planning Commission will hold an informational workshop in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on August 8, 2024, at 8:30 a.m., or soon thereafter, for the following project: A14-0004; Z14-0006; SP12-0003; DA14-0002; PD14-0005 / the Village of Marble Valley Specific Plan submitted by Marble Valley Company, LLC. The property, identified by Assessor's Parcel Numbers 087-200-074, 119-020-057, 119-030-013, 119-Numbers 087-200-074, 030-014, 119-030-015, 119-030-016, 119-030-018, 119-030-019, 119-030-017, consisting of 3,236 dwelling units on 2,342 acres, is located in the unincorporated area of the county south of U.S. Highway 50 (US 50), approximately 19 miles west of Placerville and 24 miles east of downtown Sacramento. The site is approximately 1,000 feet southeast of the US 50 and the Bass Lake Road interchange in the El Dorado Hills area, Supervisorial District 2.
