

**CONSOR North America, Inc.****SEVENTH AMENDMENT TO AGREEMENT FOR SERVICES #467-S1411**

**THIS SEVENTH AMENDMENT** to that Agreement for Services #467-S1411 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "COUNTY"), and CONSOR North America, Inc., an Oregon corporation duly qualified to conduct business in the State of California, whose principal place of business is 6505 Waterford District Drive, Suite 407, Miami, Florida 33126, and whose local address is 11017 Cobblerock Drive, Suite 100, Rancho Cordova, California 95670 (hereinafter referred to as "CONSULTANT").

**R E C I T A L S**

**WHEREAS**, CONSULTANT has been engaged by COUNTY to provide project delivery support services, including updating the feasibility study, and providing environmental support services for the Mosquito Road Bridge at the South Fork American River Project for its Department of Transportation pursuant to Agreement for Services #467-S1411, dated July 29, 2014; First Amendment to Agreement for Services #467-S1411, dated March 7, 2017; Second Amendment to Agreement for Services #467-S1411, dated August 15, 2017; Third Amendment to Agreement for Services #467-S1411, dated August 28, 2018; Fourth Amendment to Agreement for Services #467-S1411, dated March 15, 2022; Fifth Amendment to Agreement for Services #467-S1411, dated July 26, 2022; and Sixth Amendment to Agreement for Services #467-S1411, dated February 21, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to extend the expiration date of December 31, 2025 for eighteen (18) additional months, amending **ARTICLE IV, Performance Period**;

**WHEREAS**, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$224,994.33, amending **ARTICLE V, Allowable Costs and Payments**, and replacing **Exhibit C-4** with **Amended Exhibit C-4**;

**WHEREAS**, the parties hereto desire to amend the Agreement to update the provisions of the California Levine Act, replacing **Exhibit L** with **Amended Exhibit L**;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, COUNTY and CONSULTANT mutually agree to amend the terms of the Agreement in this Seventh Amendment to Agreement for Services #467-S1411 on the following terms and conditions:

- I. **ARTICLE IV, Performance Period, paragraph A** of the Article is amended in its entirety to read as follows:
- A. This Agreement shall go into effect upon execution, contingent upon approval by COUNTY, and CONSULTANT shall commence work after notification to proceed by COUNTY's Contract Administrator. The Agreement, as amended, shall expire on June 30, 2027.
- II. **ARTICLE V, Allowable Costs and Payments, paragraph H** of the Article is amended in its entirety to read as follows:
- H. The total amount payable by COUNTY, including the fixed fee, shall not exceed \$7,175,880.56, as amended.
- III. **Exhibit C-4, Cost Proposal – Phase 4**, is replaced in its entirety with **Amended Exhibit C-4, Amended Cost Proposal – Phase 4**, attached hereto and incorporated herein by reference. All references to **Exhibit C-4, Cost Proposal – Phase 4**, throughout the Agreement shall read **Amended Exhibit C-4**.
- IV. **Exhibit L, California Levine Act Statement**, is replaced in its entirety with **Amended Exhibit L, Amended California Levine Act Statement**, attached hereto and incorporated herein by reference. All references to **Exhibit L, California Levine Act Statement**, throughout the Agreement shall read **Amended Exhibit L**.

Except as herein amended, all other parts and sections of Agreement for Services #467-S1411 shall remain unchanged and in full force and effect.





California Government Code section 84308, commonly referred to as the "Levine Act," prohibits any officer of El Dorado County from participating in any action related to a contract if he or she accepts, solicits, or directs any political contributions totaling more than five hundred dollars (\$500) within the previous twelve (12) months, and for twelve (12) months following the date a final decision concerning the contract has been made, from the person or company awarded the contract. The Levine Act also requires disclosure of such contribution by a party to be awarded a specific contract. An officer of El Dorado County includes the Board of Supervisors, any elected official, and the chief administrative officer (collectively "Officer"). It is the Contractor's responsibility to confirm the appropriate "Officer" and name the individual(s) in their disclosure.
