I am proud to say that my role and expertise have resulted in zero audit findings in both our financial and performance audits for 8 consecutive years. I report to the Measure F Citizens Oversight Committee 3 times per year regarding project schedules, budgets, revenues, expenditures, audits, and community messaging for Measure F. I ensure that all expenses align with the bond measure language approved by voters, and that the COC is informed and in agreement with this. Throughout my career I have spent 17 years managing public funds, often funded by local measures, and have reported to numerous COC's across the state. I believe this experience makes me well qualified to serve on the Measure S COC.</b>
