



RESOLUTION NO. 056-2017

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the County of El Dorado Board of Supervisors is authorized to adopt new fees, fee levels, and charges, pursuant to Government Code § 54985; and

WHEREAS, the County of El Dorado's Health and Human Services Agency has reviewed and analyzed the current Emergency Medical Services Agency fee structure; and

WHEREAS, the County, having completed said analysis, which included a review of the Emergency Medical Services Agency operations (personnel, indirect and overhead, supervision and equipment costs), and a full cost recovery analysis as well as comparison against prevailing fees charged in surrounding counties, as applicable; and

WHEREAS, on September 13, 2016, the Board of Supervisors adopted and authorized Resolution 144-2016 to update fees specific to the Emergency Medical Services Agency; and

WHEREAS, effective November 8, 2016, California voters approved Proposition 64 thereby amending Health and Safety Code Section 11362.755 establishing fees charged by county health departments for Medical Marijuana Identification Cards;

NOW, THEREFORE, BE IT RESOLVED that effective November 8, 2016, this Resolution, and the fees, fee levels, and charges attached hereto as Exhibit A, "Emergency Medical Services (EMS) Agency Fees" shall be implemented, and supersede any prior written or verbal Emergency Medical Services fees specific to Exhibit A, hereto.
