ORDINANCE NO. 5231

SUMMARY OF ADOPTED
ORDINANCE
AMENDING CHAPTER 8.08 –
FIRE PREVENTION

Pursuant to California Government Code section 25124(b)(1), the County of El Dorado Board of Supervisors held a public meeting in the Board of Supervisors Meeting Room, 330 Fair Lane, Placerville, CA 95667 on June 24, 2025 to vote on the final passage of Ordinance 5231 to amend Chapter 8.08 – Fire Prevention, of Title 8, Public Health and Safety, of the El Dorado County Code of Ordinances.

This proposed ordinance amendment includes amending Section 8.08.100 – Fire Hazard Severity Zones Map, to update the title and section to clarify the area of applicability of the previously adopted 2023 Fire Hazard Severity Zones Map for certain areas within El Dorado County that are designated as Moderate, High, and Very High Fire Hazard Severity Zones effective April 1, 2024, and adding Section 8.08.200 – Local Responsibility Area Fire Hazard Severity Zones Map, to adopt the latest issued 2025 Fire Hazard Severity Map, as designated by the Office of State Fire Marshal, for certain areas within unincorporated El Dorado County that are designated as Moderate, High, and Very High Fire Hazard Severity Zones.

A full and complete copy of the full text of the adopted ordinance is available for viewing in the office of the Clerk of the Board of Supervisors at 330 Fair Lane, Placerville, CA 95667.

Pursuant to California Government Code section 25123, this Ordinance shall become effective thirty (30) days from the date of final passage by the Board of Supervisors.
