Dear Sirs :

Thank you for considering our concerns. When we bought our home on Skyline dr. we were not aware of any cell antenna's so close. We were told the tower was for airport use the antenna's themselves were obscured by the trees. We would not have bought this near microwave or RF emitters.

We live directly across the street from the existing and the proposed cite. Looking over the special use permit many concerns arise. In section F number three under maintenance once or twice a month. I can tell for a fact that this is not close to reality! In the three years that we've lived here many many companies with multiple commercial vehicles and single technicians, inspectors etc. many times taking days to perform their services. In the winter they block half the road they've even parked in our driveway at times which could be a problem on an elevated plywood driveway. There seems to be a fair amount of problems on these two cell cites

This summer Sprint finally decided on a major upgrade of the electronics. That alone was over five weeks of solid multiple commercial trucks daily. Technicians told me these upgrades will be more common as technology grows. Furthermore initial construction of a new tower and base unit will be many more weeks of non residential impact.

And the addition of possibly two more carries (under project description) would result in five.

This will no longer be a residential neighborhood!

One of the projects this summer was to be the removal of the existing electronics in the garage under the master bedroom of the house where 1 person died of breast cancer and 1 of brain cancer.

The new occupants are still waiting and now not sure if they want to stay. The corporation is pushing for another contract to leave everything as is. How can we trust them?

The previous occupant rented a meter to test for safe levels and a few days later she moved out. She said the levels were way too high and noone should live there.

FCC Approved and safe ???

Is it responsible to ignore peoples health concerns simply because the FCC says its safe?

So many products, foods, drugs, and factories have had government set and regulated safe levels.

Yet TV and news are full of stories and law suites where safe levels resulted in sickness or death

It seems that long term human exposure is the real test for what safe levels really are. Resulting in newly adjusted safe levels. (suprise)

How many towers will be allowed in our neighborhood? What's to stop them from getting a ~~an~~ Special Use Permit and overruling residential zoning. We don't want this new tower. We don't want the two existing cell sites that no one had any say in. Please put them in another location away from homes. All the neighbors I know feel the same way.

As far as property values are concerned all the letters you've received and all the attendees ~~at~~ the meeting and all those who wanted to come but couldn't. These represent people that would be concerned and probably not buy a home near cell towers. The percentage would be in the majority. Of course this will affect the ability to sell our home.

You will decide who has more right to our lives. Do we or do corporations.

As your friends and neighbors I hope you can sympathize with us.

if this tower is forced on us we will relocate too. We would like to live in a peaceful quiet low stress environment.
