Pursuant to Section 22.C. of that certain Solid Waste Services Agreement, dated as of August 23, 2004, as amended by that certain First Amendment of Solid Waste Services Agreement, effective January 1, 2010 (together, the 'Agreement'), we are formally requesting that the County implement the automatic CPI adjustment for our hauling rates as well as our Transfer Station gate rates as provided for in Section 22.C of the Agreement. We have attached a copy of the Division of Labor Statistic and Research CPI calculator as the reference. As you will see, the increase in the Consumer Price Index N All Items N N All Urban Consumers- California for the point to point period of December 2011 to December 2012, was 2.0%. Per the 'Agreement' we are entitled to the change of 2.0%, effective July 1, 2013.
