AGREEMENT FOR SERVICES #154-S0711  
AMENDMENT II

This Amendment II to that Agreement for Services #154-S0711, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and R.E.Y. Engineers, a California corporation, duly qualified to conduct business in the State of California, whose principal place of business is 905 Sutter Street, Suite 200, Folsom, CA 95630; (hereinafter referred to as "Contractor");

**WITNESSETH**

**WHEREAS**, Contractor has been engaged by County to provide plan review services on an "as requested" basis as necessary for project development for the Development Services Department, in accordance with Agreement for Services #154-S0711, dated August 22, 2006. and Amendment I, dated August 16, 2007, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to extend the term of said Agreement for one (1) additional year and increase compensation, hereby amending **ARTICLE II – TERM and ARTICLE III – Compensation for Services**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #154-S0711 shall be amended a second time as follows:

**ARTICLE II**

**Term:** This Agreement shall become effective upon execution by both parties hereto and shall cover the period August 22, 2006 through August 20, 2009.


**ARTICLE III**

**Compensation for Services:** For services provided herein, County agrees to pay consultant monthly in arrears. Payment shall be made within thirty (30) days following the County's receipt and approval of invoice(s) identifying services rendered. For the purposes hereof, the billing rates shall be in accordance with Revised Exhibit "B", marked "2008 Fee Schedule", incorporated herein and made by reference a part hereof. Travel and/or mileage expenses, if applicable, shall be made in accordance with Exhibit "C", marked "Board of Supervisors Policy D-1", incorporated herein and made by reference a part hereof.


The total amount of this Agreement shall not exceed \$70,000.00, inclusive of all expenses.

Outside reproductions, services, and consultants will be charged at cost plus 10%.

In-house large format reproduction will be charged at \$0.30/SF.
