Background: The California Governor's Office of Emergency Services (Cal OES) approved FY 2019 Public Safety Power Shutoff (PSPS) funds in the amount of \$399,490 for El Dorado County.

Priorities: Public safety, Continuity of Government, County cost avoidance/risk mitigation, Benefits to multiple agencies

Radio Repeater Generator Unit	Logtown Fire Station	\$12,000	Communications for Fire/Law radios.
Radio Repeater Generator Unit	Sliger Mine Fire Station	\$12,000	Communications for Fire/Law radios.
Radio Repeater Generator Unit	Willows Fire Station	\$12,000	Communications for Fire/Law radios.
Generator	Placerville Jail	\$75,000	Additional generator to power laundry, kitchen, secure areas.
Generator infrastructure for other County Facilities	Building A Briw Road Spring Street Portable Gens.	\$218,490	Generators and/or infrastructure to provide redundant power for County facilities.
Continuity of Operations (COOP) Planning	Countywide	\$35,000	Funding for County-wide COOP Planning

Project	Location	Estimated Cost	Discussion/Notes
Generator	North County	Unknown	Difficult to justify facility use. Not recommended at this time.
Generator	Pioneer Park	Unknown	Difficult to justify facility use. Not recommended at this time.
Hard Wire Facility – Cameron Park CSD	Cameron Park	Unknown	Need estimated cost for hard wiring, There is a \$1,100 fee to conduct the assessment. Large facility. Would have multiple uses (e.g. community sheltering, etc.). Would need to put in place an agreement with Cameron Not recommended at this time.
Generator - Fairgrounds	Placerville	\$100,000	Difficult to justify facility use. Not recommended at this time.
Generator – Animal Services	Diamond Springs	Unknown	Was not impacted by PSPS events, so far. Not recommended at this time.
Generator – Veterans Hall	Placerville	Unknown	Difficult to justify facility use. Not recommended at this time.
EOC Equipment Upgrade – Sheriff’s Office	Diamond Springs	\$42,000	Does not appear to be allowable use of funds; recommend identifying other funding streams. Not recommended at this time.
