#### **RECOMMENDATION:**

The Department of General Services recommends that the Board of Supervisors:

- 1. Approve Bid Documents for South Lake Tahoe Animal Shelter Remodel, Bid # 07-968-103, and authorize Chairman to execute same; and
- 2. Authorize the Department of General Services to advertise project with Bids due no later than 2:00 p.m., Friday, March 16, 2007.

#### **REASON FOR RECOMMENDATION:**

The animal shelter facility will be increase in size by approximately 760 square feel for improved staff efficiency and public service. ADA access will be provided from a new level parking lot and throughout the building. The animal housing is being updated to allow for improved public viewing and maintenance by county personnel.

General Services is ready to advertise the Bid pending approval by the Board. Bids will be due no later than 2:00 p.m., on Friday, March 16, 2007. A copy of the bid document is on file with the Board Clerk's Office.
