FIRST AMENDMENT TO OFFSITE ROAD IMPROVEMENT AGREEMENT FOR THE CROSSINGS AT EL DORADO, MISSOURI FLAT ROAD AND CROSSINGS ROAD, PD97-0011 BETWEEN COUNTY AND THE DEVELOPER

THIS FIRST AMENDMENT, to that certain Road Improvement Agreement (hereinafter referred to as the "Agreement"), made and entered by and between the COUNTY OF EL DORADO, a political subdivision of the State of California, (hereinafter referred to as "County"), and L L L & A LLC, a limited liability company, duly qualified to conduct business in the State of California, whose principal place of business is 4330 Golden Center Drive, Suite D, Placerville, California 95667 (hereinafter referred to as "Developer"); concerning the offsite road and drainage improvements for THE CROSSINGS AT EL DORADO, MISSOURI FLAT ROAD AND CROSSINGS ROAD, PD97-0011, PROJECT (hereinafter referred to as "Project"); in accordance with the improvement plans entitled Road Widening Improvement Plans for The Crossings at El Dorado Missouri Flat and Crossings Road APN:327-130-001, 327-130-002 El Dorado County CIP# 71374 and cost estimates prepared by RSC Engineering, Inc., James H. Vanderpost, P.E., Registered Civil Engineer, and approved by Dave Spiegelberg, Senior Civil Engineer, Transportation Planning and Land Development, Department of Transportation (hereinafter referred to as "Transportation").

RECITALS

WHEREAS, County, and Developer entered into that certain Road Improvement Agreement on August 30, 2022, in connection with the Project, copy of which Agreement is incorporated herein and made by reference a part hereof;

WHEREAS, Section 4, entitled TIME, of the Agreement, requires Developer to complete the offsite improvements thereunder on or before August 30, 2024, and Developer has not completed all of the improvements but has requested an extension of time to complete the improvements subject to the terms and conditions contained herein, to August 30, 2025;

NOW, THEREFORE, the parties hereto, in consideration of the recitals, terms and conditions herein, do hereby agree to amend the terms of the Agreement in this **First** Amendment to read as follows:

I. Section 4 is amended to read as follows:

SECTION 4. TIME

Developer shall cause the commencement of items of work after County approved the Plans for the Project on May 9, 2022, and shall complete the Project no later than three (3) years from the effective date of this Agreement, subject to extensions for delays not within the control of the Developer. Construction activities shall be between 7:00 a.m. and 7:00 p.m. Mondays through Fridays; and 8:00 a.m. and 5:00 p.m. on weekends and federally recognized holidays. Night work may be allowed within the County Right of Way with prior written approval.

Except as herein amended, all other parts and sections of that certain Agreement dated August 30, 2022, shall remain unchanged and in full force and effect
