



## RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

### RESOLUTION ESTABLISHING THE ANNUAL BENEFIT ASSESSMENT FOR THE 2008/09 TAX YEAR FOR ROAD ZONES OF BENEFIT WITHIN COUNTY SERVICE AREA #9

**WHEREAS**, the Board of Supervisors of the County of El Dorado has formed County Service Area #9 pursuant to Title 3, Division 2, Part 2, Chapter 2.2 of the California Government Code, and within that County Service Area (CSA) established zones of benefit; and

**WHEREAS**, the Advisory Committees for the eighteen road zones shown on Exhibit A have recommended to the Board that it continue to impose the established benefit assessments in the amounts also shown on Exhibit A for the purpose of providing road improvement and maintenance services within the zones of benefit; and

**WHEREAS**, the Board of Supervisors of the County acting as the governing Board of CSA #9 finds that the benefit assessments are apportioned to the estimated benefit derived from the special services provided within each zone; and

**WHEREAS**, election or majority ballot procedure pursuant to Proposition 218 is not required as the benefit assessments are a continuation of previous benefit assessments in the same or lower amounts and are therefore exempted; and

**WHEREAS**, a public hearing was scheduled for June 17, 2008 and was noticed as required by Government Code §25210.77a; and

**WHEREAS**, on June 17, 2008, after public hearing, the Board determined that no majority protest was registered against establishing the proposed assessments within the zones of benefit.

**NOW, THEREFORE, BE IT RESOLVED** that the Board determines as follows:

1. The benefit assessments as shown on Exhibit A are hereby adopted for the fiscal year 2008/09
2. The benefit assessments shall be distributed in accordance with the final budgets for the zones, as approved by the Board of Supervisors during County budget hearings and amendments thereto.

- 3. The services to be provided are extended county services as defined on County Service Area Law, Government Code §25210.1
- 4. The benefit assessments levied and collected are apportioned according to the estimated benefit derived from the road improvement and maintenance services provided within each zone.
- 5. The benefit assessments are a continuation of the previous benefit assessments in the same or lower amounts.
- 6. The levy and collection of the benefit assessments is exempt from election or majority ballot procedure under Proposition 218.

**BE IT FURTHER RESOLVED**, that the assessments as adopted and confirmed shall appear as separate item on the tax bill for each parcel and shall be levied and collected in the same manner as County ad valorem taxes are collected, as more specifically set forth and authorized on subdivision (d) of §25210.77a of Government Code.
