Please vote yes on 21-1497 for the Sheriff's Office, recommending: 1) Authorize and approve the Chair to sign Lease agreement 5984 with WFC Cameron Park, LLC for the Sheriff's Substation located at [3332 Coach Lane, Cameron Park, CA 95682](#) for the term February 1, 2022, through January 31, 2024, in the not to exceed amount of \$36,000; and 2) Authorize the Purchasing Agent, or designee, to execute further documents related to the lease agreement including future Amendments contingent upon approval by County Counsel and Risk Management.
