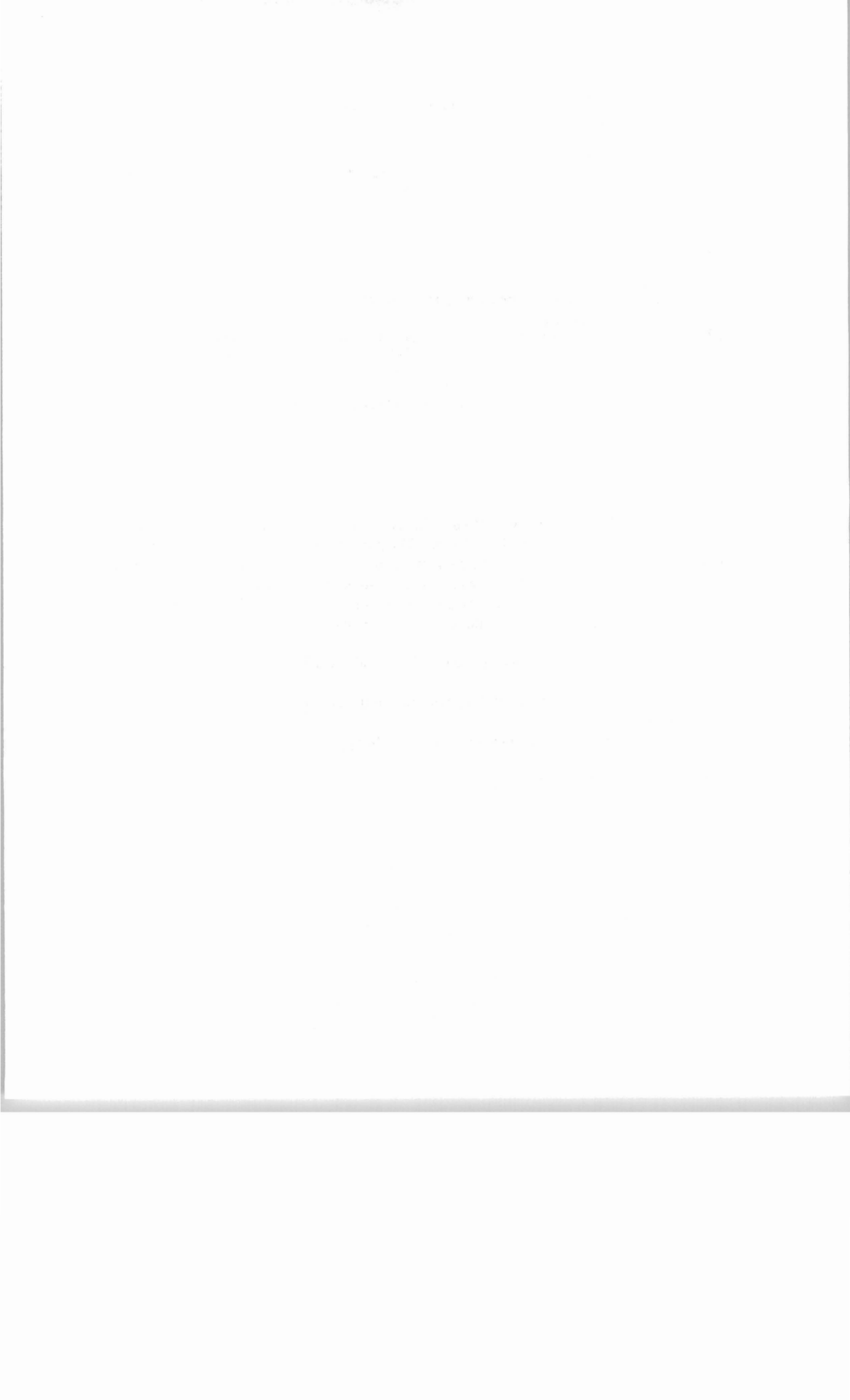
This item will be on the August 28, 2007 agenda and would like to seek your approval to rezone and split this parcel.
