

Summary of qualifications I have practiced law for nearly 13 years. During that time I represented individuals in all manner of criminal cases, from misdemeanors to strike felonies. Now, I mostly practice family law. Prior to my practicing law, I graduated from Santa Clara School of Law and UC Berkeley. During law school, I was President of the Criminal Law Society and won a Witkin Award for legal research and writing.			
Affiliations with professional and/or community groups I am a Trustee for the Gold Trail School District. I have served in that role since December 15, 2022. I am also a member of the Gold Trail Grange in Coloma. I am a member of the State Bar and a monetary supporter of the American River Conservancy.			
Why do you seek appointment? I seek appointment to the Law Library Board because I want to help ensure that the public has access to excellent legal research materials and assistance so that they can have access to justice within our county. Further, I have a personal interest in a well-functioning library because I use the library frequently to research issues within and outside my practice areas.			
Additional Information I am a firm believer in the rule of law and think that it is essential for a free and fair society. Further, I believe that for people to have faith in the rule of law, they need to be able to competently access the legal system. Legal representation can be extremely expensive, and, considering that fact, it can be difficult for middle- and low-income people to competently access the legal system to solve their disputes and other problems. A well-functioning law library is therefore necessary because it provides the materials and support needed to make the legal system accessible and viable for people without the means to hire an attorney.
