Culverts, Pipes and Couplers
General: The El Dorado County Procurement \& Contracts Division is requesting bids for the purchase of culverts, pipes and band couplers, for the Department of Transportation. Purchases will be made on an "as requested" basis for the thirty-six (36) month award period following the bid award. Prices shall remain firm for the awarded thirty-six (36) month period unless all conditions of the "Escalation Clause" have been met (see Page seven [7]). Quantities indicated on the Quotation Schedule are an estimated annual usage; the County makes no guarantee as to the total amount to be purchased during the awarded period. Term to start on approximately April 20, 2023.

Additional purchases for like items not listed on the Quotation Schedule may be made during the awarded period; bidders must provide a written quote for these additional purchases, see Page thirteen (13) for specific details on additional purchases.

1) All metal culverts to be corrugated metal pipe with a wall thickness of .079 inches ( 14 gauge).
2) All metal culverts to be of helical corrugation type with standard re-corrugated ends.
3) All band couplers to be universal dimple band type with carriage bolts included.
4) All plastic culverts to be double wall and smooth bore.

Requirements: Bidders failing to comply with any of the following requirements will not be considered for the evaluation and award process:

1) Bidders must quote $\mathbf{1 0 0 \%}$ of all categories listed on the Quotation Schedule. Failure to bid $100 \%$ of all items and categories will result in your bid being rejected as non-responsive.
2) Delivery must be made within ten (10) days after receipt of order.
3) No minimum ordering requirements will be accepted.
