PROGRAM NARRATIVE

1. OBJECTIVES

An Application for Federal Aviation Administration Airport Infrastructure Grant funds has been prepared for the design of Airport Obstruction Removal - Part 77 project proposed to be included in the 2024 Airport Infrastructure Grant at the Placerville Airport, Placerville, El Dorado County, California. A description of this project is as follows:

Trees exist in the Part 77 surface area at the Placerville Airport that were identified as obstructions to these surfaces in the AGIS and ALP in 2020. These obstructions will need to be removed. The engineering design of this project is included in this application

2. RESULTS OR BENEFITS EXPECTED

The removal of obstructions to the Part 77 surfaces will provide safety of aircraft operations at the Placerville Airport.

3. APPROACH

Plan of Action - All airport design will conform to Advisory Circular 150/5300-13B, *Airport Design*. Specifications will be prepared based on Advisory Circular 150/5370-10H, *Standards for Specifying Construction of Airports*. All safety requirements as outlined in Advisory Circular 150/5370-2G, *Operational Safety on Airports During Construction* will be included in the Construction Safety and Phasing Plan prepared for this project.

The engineering will be performed as follows:

Phase 1 – Preliminary

Perform Environmental Studies.

Phase 2 - Engineering Design and Preparation of Plans and Specifications

- a) Perform complete engineering design.
- b) Prepare complete plans and specifications for the project, ready for bid.
- c) Prepare Engineer's Report, including engineer's estimate of construction costs for the proposed project, and Construction Safety and Phasing Plan.

Phase 3 - Engineering Support During Bidding and Contract Award

- a) Assist County in distributing final plans and specifications to prospective contractors.
- b) Participate in a pre-bid meeting for all prospective contractors.
- c) Respond to any questions and comments from prospective contractors.
- d) Preparation of required addenda.
- e) Assist County in awarding contract including preparation of Abstract of Bids, evaluation of bids, and preparation of the final Application for AIP funds.

4. **GEOGRAPHIC LOCATION**

The project included in this application will be at the Placerville Airport located in Placerville, El Dorado County, California. The areas to be served will be the Placerville Airport and areas of El Dorado County that will be served by the airport improvements.

The Federal Aviation Administration (FAA) has reviewed the environmental information you submitted for the Proposed Obstruction Removal Project at the Placerville Airport (PVF), Placerville, California. The enclosed figure highlights the area of the proposed project. The FAA has determined the proposed project is Categorically Excluded pursuant to FAA Order 1050.1F as it relates to the National Environmental Policy Act of 1969, as amended (NEPA). Therefore, no further federal environmental disclosure documentation for the project components is necessary for NEPA purposes.

This letter notifies you that the proposed project has complied with NEPA only. This is not a notice of final project approval of funding availability.

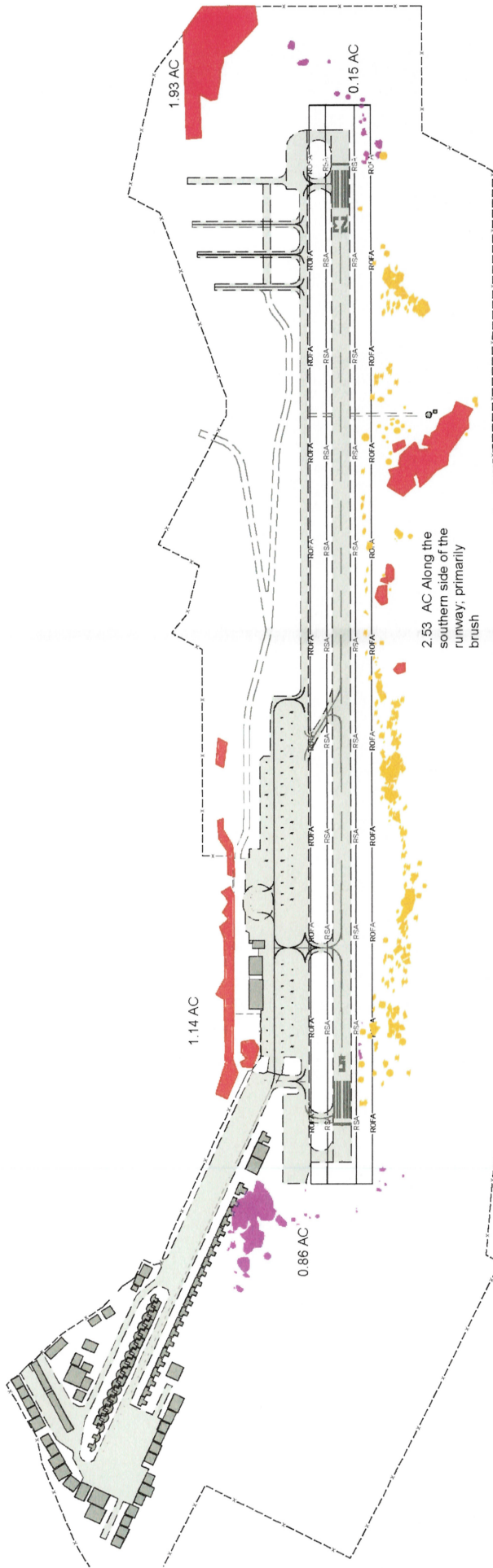

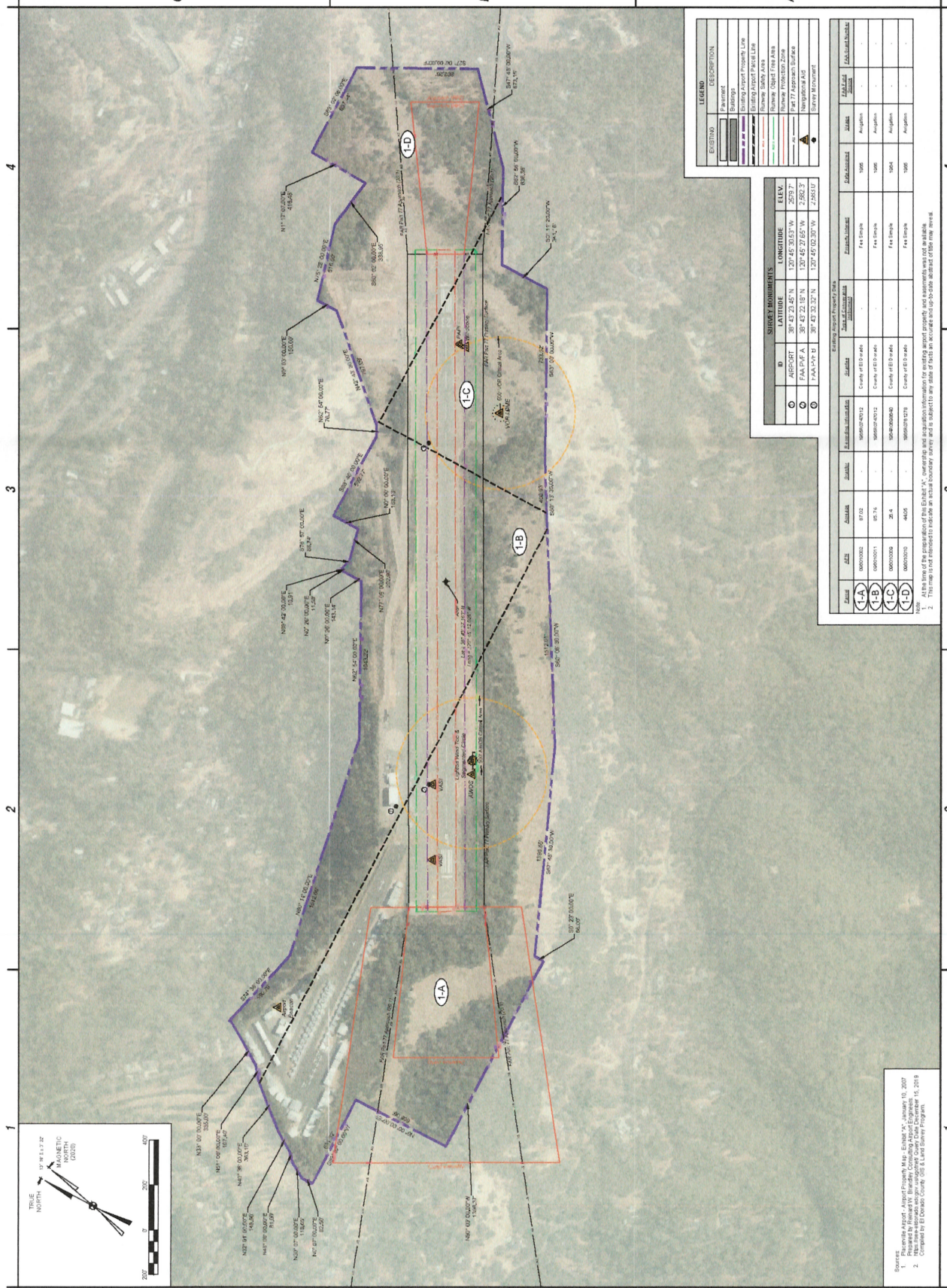

It will provide for such methods of administration for the program as are found by the Secretary of Transportation or the official to whom he delegates specific authority to give reasonable guarantee that it, other sponsors, subgrantees, contractors, subcontractors, transferees, successors in interest, and other participants of Federal financial assistance under such program will comply with all requirements imposed or pursuant to the Act, the Regulations, and this assurance.
8. It agrees that the United States has a right to seek judicial enforcement with regard to any matter arising under the Act, the Regulations, and this assurance.

ATTACHMENT 1

During the performance of this contract, the contractor, for itself, its assignees and successors in interest (hereinafter referred to as the "contractor") agrees as follows:

1. Compliance with Regulations. 4. Information and Reports. The contractor shall provide all information and reports required by the Regulations or directives issued pursuant thereto and shall permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the Sponsor or the Federal Aviation Administration (FAA) to be pertinent to ascertain compliance with such Regulations, orders, and instructions. 




