Current Population: 15 (9 males, 5 females and additional scheduled to come in tonight)

11 youth from El Dorado County, 4 Out of County (Marin, Lassen, Del Norte and one coming in tonight 19yr old is also from out of the county) 2 of the 4 Out of County are housing only (maybe due to staffing issues at other county)

10 releases since July 22, 2025

2 suicide attempts – same youth. MH involved and additional supports and procedures
