



RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**Authorization for the Health and Human Services Agency's Director, or Designee,
to Execute and Administer Specific Allocations
Issued by the California Department of Health Care Services.**

WHEREAS, in accordance with Board of Supervisors' (hereinafter referred to as the "Board") Policy A-6 "Grant Applications," the Board of Supervisors is the sole authority for accepting grant awards and approving grant agreements. After acceptance of a grant award and approval of the grant agreement, the Board may delegate authority to execute the grant agreement and other grant related documents; and

WHEREAS, the California Department of Health Care Services (DHCS) issues annual funding allocations (Allocations) to the Health and Human Services Agency (HHSA), including, but may not be limited to: 1) Projects for Assistance in Transition from Homelessness (PATH); and 2) Community Mental Health Block Grant (MHBG) (Allocations), that require signature of HHSA's Director of Behavioral Health; and

WHEREAS, these Allocations are vital to HHSA's ability to provide necessary and mandated services to the community and residents of the County; and

WHEREAS, DHCS has issued these Allocations and revised Allocations after the start date and the timeline allowed by DHCS to execute and submit documents is brief, resulting in a significant workload impact for HHSA, County Counsel, Risk Management, the Chief Administrative Office, and the Board; and

WHEREAS, the additional time required to prepare for and receive approval from the Board to accept the funding and to execute these Allocations reduces the period of time costs may be charged against DHCS Allocations and results in costs charged to other funding sources, including General Fund; and

WHEREAS, the funding realized by these Allocations is included annually in HHSA's operating budget; and

WHEREAS, to ensure the timely and efficient processing of Allocations, thereby safeguarding the continuation of essential services, the Board of Supervisors hereby authorizes the HHSA Director, or designee, to act on behalf of the County of El Dorado through June 30, 2022, and accept these Allocations and execute all necessary documents required to secure and maintain these Allocations, contingent upon approval by County Counsel and Risk Management, as applicable.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado does hereby:

- 1) Delegate authority to the HHSA Director, or designee, on behalf of the County, through June 30, 2022, in accordance with Board of Supervisors Policy A-6, to accept funding from DHCS and execute these Allocations and all necessary documents, contingent upon approval by County Counsel and Risk Management, as applicable; and
- 2) Approve and authorize the HHSA Director, or designee, to continue to administer these Allocations, authorize the HHSA Director of Behavioral Health to execute programmatic reports, and further authorize HHSA's Agency Chief Fiscal Officer to execute any required fiscal reports.
