RESOLUTION OF VACATION**

**Abandonment of Easement #07-0008**

**Amended Final Map for a Portion of the Summit Unit No. 2, Lot 117**

**John S. Boutselis & Joan C. Boutselis Trustees under Declaration of trust dated June 12, 1987**

**WHEREAS**, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

**WHEREAS**, public utilities easements, as shown on the Amended Final Map for a Portion of the Summit Unit No. 2 final map, were irrevocably offered in perpetuity to the County of El Dorado in February of 1999 and accepted by the Board of Supervisors in March of 1999; and

**WHEREAS**, the Department of Transportation has received an application from John S. Boutselis & Joan C. Boutselis Trustees under Declaration of trust dated June 12, 1987, owners of Lot 117, requesting that the County of El Dorado vacate public utilities easements located on the rear and side boundary lines of Lot 117; and

**WHEREAS**, A T & T, Comcast, El Dorado Irrigation District, and Pacific Gas & Electric have not used said easements for the purpose for which they were dedicated or acquired; and find that no present or future need exists for said easements and do not object to their vacation; and

**WHEREAS**, all other existing easements will remain; and

**WHEREAS**, the Department of Transportation has determined that said easements herein described in Exhibit "A" and depicted in Exhibit "B", and made a part hereof, have not been used for the purpose for which they were dedicated preceding the proposed vacation, and has no objection.

**NOW, THEREFORE BE IT RESOLVED**, that from and after the date this Resolution is recorded, said public utilities easements described in Exhibit "A" and depicted in Exhibit "B" are vacated and no longer constitute public utilities easements. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
