1.01	Notice to Bidders, Page N-2, CONTRACTORS LICENSE CLASSIFICATION	Bidders are advised that the CONTRACTORS LICENSE CLASSIFICATION section is amended to require either a Class A – General Engineer contractor license or a Class C10 – Electrical contractor license and is hereby replaced in its entirety with the following:
		CONTRACTORS LICENSE CLASSIFICATION: Bidders shall be properly licensed to perform the Work pursuant to the Contractors' State License Law (Business and Professions Code section 7000, et seq.) and shall possess either a California Class A – General Engineering Contractor's License or a California Class C10 – Electrical Contractor's License at the time the bid is submitted and shall maintain a valid license and certification through completion and acceptance of the Work, including the guarantee and acceptance period. Failure of the successful Bidder to obtain proper adequate licensing shall constitute a failure to execute the Contract and shall result in the forfeiture of the Bidder's security and may result in legal penalties.

		Article 35. LICENSES
		Contractor warrants and represents that it holds a valid California license pursuant to the Contractors' State License Law (Business and Professions Code section 7000, et seq.), that its license is in good standing and that it possesses either a Class A – General Engineering Contractors License or a Class C10 – Electrical Contractors License as required by the categories and type of the Work. Copies of Contractor's State Contractors' license must be provided with this Agreement.
		In addition, Contractor hereby represents and warrants that Contractor and any of its subcontractors employed under this Agreement has all the applicable licenses, permits, and certifications that are legally required for Contractor and its subcontractors to practice its profession or provide the services or work contemplated under this Agreement in the State of California. Contractor and its subcontractors shall obtain or maintain said applicable licenses, permits, or certificates in good standing throughout the term of this Agreement.
