Schilling Robotics wants to keep its manufacturing operations in El Dorado County, but the county is looking for a shelter.

Schilling makes deep ocean robots used for science, technology and industry. Some of its robots are currently in the Gulf of Mexico Oil spill, which is more than 1 mile deep on the ocean floor.

The company employs 35 people and has invested more than \$2 million at its precision manufacturing machinery.

Springs. The company has a five-year lease, but the 50,000-square-foot building went back to its lender in a foreclosure. Now, the county wants to buy the building and convert it to a new animal shelter.

The El Dorado County Board of Supervisors will consider the action at its meeting Tuesday.

Schilling wants to continue operating in the Shingle Springs location because its employees are there and few have moved to other areas.

Based in Davis, Schilling was founded in 1985. It has offices in Davis, El Dorado Hills, Houston and Aberde
