

The El Dorado Hills Community Services District ("District") appreciates this opportunity to respond to the request for comments on the above referenced project. The District had already provided a letter of support of the project dated June 12, 2019. The District has reviewed the information provided regarding the applicant's request for the relocation of the El Dorado Irrigation District's ("EID") Bass Lake wastewater collection facility to their existing El Dorado Hills wastewater treatment plant. The District is in full support of the relocation.

The District is currently in the acquisition process for the 14.74-acre Bass Lake property APN 11540022 owned by EID where the Bass Lake wastewater collection facility is currently operating. Once the acquisition is complete, the District will be moving forward with the development of a regional park. In order to complete construction of the regional park, EID will have to vacate the property.

As EID already owns land and operates a wastewater treatment plant within the El Dorado Hills boundaries, it would be beneficial to residents and EID operations to combine the two locations.
