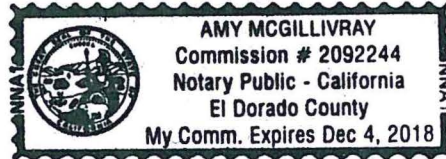

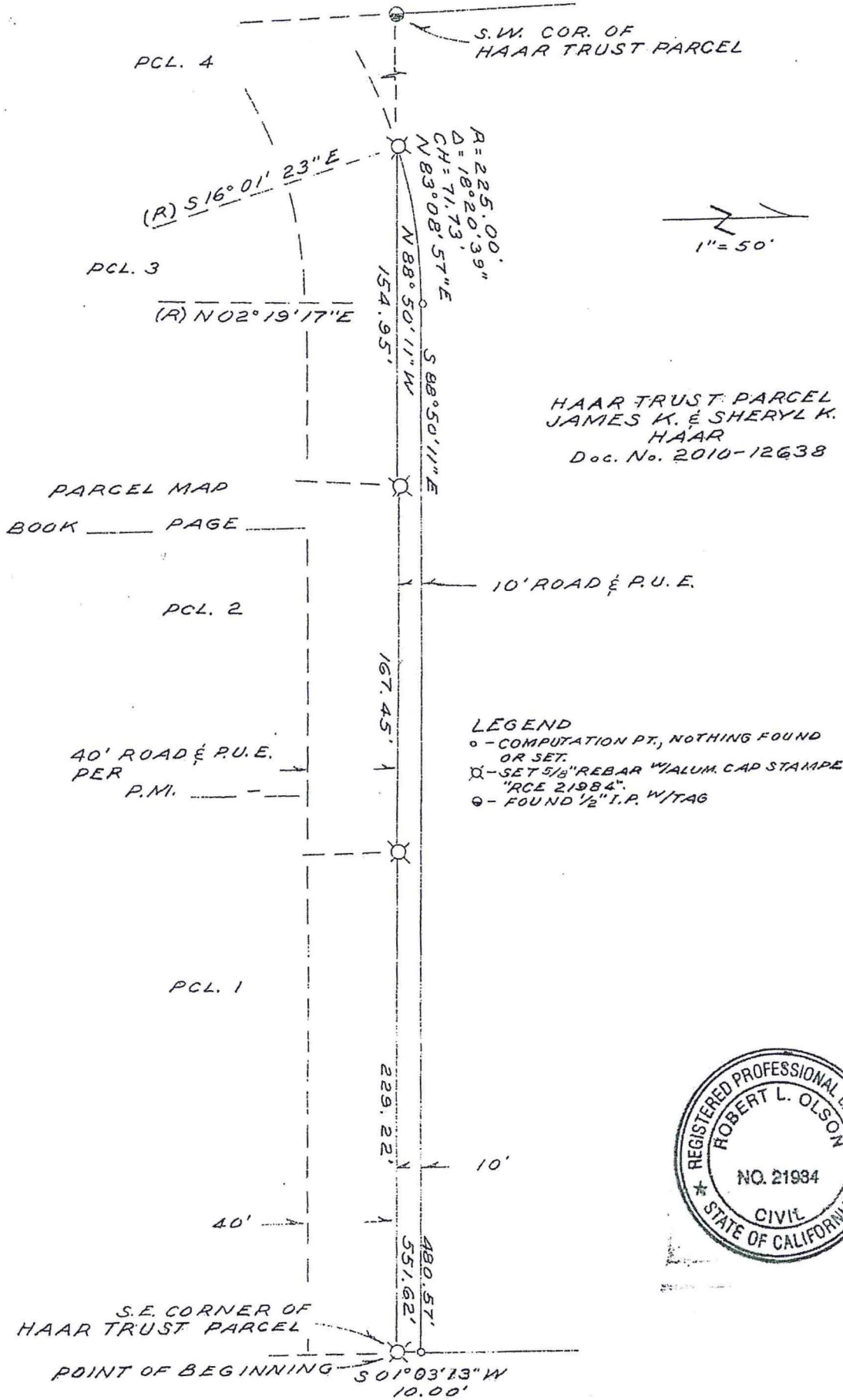

Haar Trust Parcel (Haar Trust Parcel) as described in that Grant Deed recorded in the Office of the El Dorado County Recorder on March 23, 2010 at Document # 2010-12638, being a portion of Lot 4 of the Southwest Quarter of Section 30, Township 11 North , Range 13 East, M.D.B.&M. described as follows:

A strip of land for a Road and Public Utility Easement, 10 feet wide where measurable at right angles, more particularly described as follows:

BEGINNING at the Southeast Corner of said Haar parcel, a point marked by a  $\frac{5}{8}$ " rebar with an aluminum cap stamped "RCE 21984" ; thence, along the South line of said Haar Parcel, North  $88^{\circ} 50' 11''$  West, (CITE: North  $88^{\circ} 40' 00''$  West) 551.62 feet to a similar rebar and cap: thence along a non-tangent curve to the right with a radius of 225.00 feet and chord of North  $83^{\circ} 08' 57''$  East, 71.73 feet to a point of tangency; thence along a line 10 feet north of, and parallel with, said South line of said Haar Parcel, South  $88^{\circ} 50' 11''$  East, 480.57 feet to the East line of said Haar Parcel; thence along said East line of said Haar Parcel South  $01^{\circ} 03' 13''$  West, (CITE: South  $01^{\circ} 33' 30''$  West) 10.00 feet to the Point of Beginning and containing 0.122 acre (5,299 sq. ft.).
