# RESOLUTION NO. 034-2010

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

### Resolution of Road Closure for the "Every Fifteen Minutes" Safety Presentation at Oak Ridge High School

**WHEREAS**, the El Dorado Hills Fire Department, California Highway Patrol (CHP) and Oak Ridge High School (sponsors) desire to hold the "Every Fifteen Minutes" Safety Presentation on Tuesday, April 6, 2010, from 8:00 AM to 11:00 AM, sanctioning the road closure of Harvard Way between the intersections of Silva Valley Parkway and Clermont Lane in El Dorado Hills, El Dorado County, and;

**WHEREAS**, said sponsors have applied for a Road Closure Permit pursuant to Vehicle Code 21102(e), Ordinance Code §12.37.010 et seq., and County Resolution 110-79, in order to restrict usage on Harvard Way in El Dorado Hills during this "staged" collision scene. Participants to include: Junior and Senior students from Oak Ridge High School (students to be located in bleachers adjacent to the collision scene for observation purposes); Emergency Personnel from the El Dorado Hills Fire Department; El Dorado County Coroner's Office; and CHP (including helicopter medivac);

**WHEREAS**, the road closure will be managed by CHP personnel throughout the entire event. The traffic management plan will only prohibit vehicles from accessing Oak Ridge High School.

**NOW THEREFORE BE IT RESOLVED** that Harvard Way be fully closed between Silva Valley Parkway and Clermont Lane on Tuesday, April 6, 2010, from 8:00 AM to 11:00 AM subject to the conditions set forth in Resolution No. 110-79 dated May 1, 1979, and subject to the conditions set forth in the Application for Road Closure submitted for this event.

This Resolution and the Application with conditions shall together constitute the Road Closure Permit.
