Okay. So I reviewed the original contract. You already have a 34 cap on the account with 5 years left on the contract. With the additional 7 users added it would bring you to a total of 100 users.

By adding the 5 new user seats to the site now, there would be a prorated amount billed to you from the time the seats are added through September 30th, 2021.

Then, with 100 users starting 10/1/2021

Year 3 = 11,166.25
Year 4 = 11,604.23
Year 5 = 11,952.35
Year 6 = 12,310.42
Year 7 = 12,680.24
