

AGREEMENT FOR SERVICES #375-169-M-E2011 AMENDMENT II

This Amendment II to that Agreement for Services #375-169-M-E2011, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as COUNTY) and Turning Point Community Programs, a California Corporation (hereinafter referred to as CONTRACTOR).

RECITALS

WHEREAS, CONTRACTOR has been engaged by COUNTY to provide a Wellness Outreach Program for Vulnerable Adults for the County of El Dorado Health Services Department, Mental Health Division in accordance with Agreement for Services #375-169-M-E2011, dated March 11, 2011, and Amendment I, dated June 28, 2011, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend *Article IV - Compensation for Services;* and

WHEREAS, the parties hereto have mutually agreed to amend *Article XII - Notice to Parties*; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #375-169-M-E2011 shall be amended a second time as follows:

1) Article IV, Compensation for Services, Section 4.06 only, shall be amended to read as follows:

Section 4.06 Not-to-Exceed: \$90,000 over the term of this Agreement.

2) Article XII - Notice to Parties, shall be amended in its entirety to read as follows:

Article XII. NOTICE TO PARTIES

All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested.

Notices to COUNTY shall be addressed as follows:
