Irrevocable Offer of Dedication #08-0005

Assessor's Parcel Number 074-300-03**

dated October 13, 1992**

WHEREAS, the authority to invoke the process of dedicating an easement over, under and/or across property by the County is established under Section 7050 of the California Government Code and Section 66475 of the Subdivision Map Act; and

WHEREAS, the authority to accept right of way, road, slope, drainage and public utilities easements by the County, at its discretion, is established under Section 7050 of the California Government Code and Section 66477.1 of the Subdivision Map Act; and

WHEREAS, Larry Niegel, Karen Niegel, and Robert H. Ellinghouse, Trustee of the Ellinghouse Family Trust dated October 13, 1992, have executed an Irrevocable Offer of Dedication to the County of El Dorado for road right of way and public utilities easement situated on Tract 3 of RS #23/50, also identified as Assessor's Parcel Number 074-300-03, and is located in the unincorporated area of Greenwood; and

WHEREAS, said road right of way and public utilities easement is described in Exhibit A and depicted in Exhibit B attached to said offer; and

WHEREAS, said offer shall remain in effect and run with the land until such time the County of El Dorado Board of Supervisors accepts said offer by Resolution; and

WHEREAS, the County of El Dorado Board of Supervisors has determined that it is in the public's best interest to acknowledge but reject said offer at this time.

NOW, THEREFORE BE IT RESOLVED, that from and after the date this Resolution is recorded, said offer for road right of way and public utilities easement is hereby acknowledged but rejected at this time, by the County of El Dorado Board of Supervisors.
