This Amendment IV to that Tower License Agreement #356-O0010 (#669), made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "Tenant") and Global Tower Assets III, LLC, a Delaware Limited Liability Corporation, as successor-in-interest to the Agreement, whose principal place of business is 10 Presidential Way, Woburn, MA 01801(hereinafter referred to as "Owner");

**RECITALS**

**WHEREAS**, Tenant has been granted by Spectrum Resources Towers, L.P., predecessor, in interest to owner, the non-exclusive right to install, maintain, operate and remove radio communication equipment and appurtenances on the Tower located at Genoa Peak Site ("Premises") in Carson City, Nevada; licenses to a portion of the Premises for the placement and operation of its equipment; and a non-exclusive easement during the term of Tower License Agreement #356-O0010 (#669) for reasonable ingress and egress to the Tower and Premises, in accordance with Tower License Agreement #356-O0010 (#669), commencing on November 1, 1999, incorporated herein and made by reference a part hereof; and

**WHEREAS**, Owner is the successor-in-interest to the original owner of the Premises, as memorialized in Amendment IV to the Agreement; and

**WHEREAS**, the parties desire to change where and to whom rent payments under the Agreement should be directed, in recognition of Owner's status as a pass-through entity for tax purposes; and

**WHEREAS**, the parties wish to permit each party to change its notice address and information by providing written notice to the other party rather than requiring an amendment to the Agreement; and

**NOW THEREFORE**, the parties do hereby agree that Tower License Agreement #356-O0010 (#669) shall be amended a fourth time as follows:

25. **Notices/Payment.** All notices, requests, demands, due and past due payments and other communications hereunder shall be in writing and shall be deemed given if personally delivered or mailed, by certified mail return receipt requested, or by overnight service having a record of receipt to the addressed indicated below:


