

RESOLUTION NO. 134-2018

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, County provides pre-hospital Advanced Life Support services and dispatch services under a public utility model to the residents of the County of El Dorado; and

WHEREAS, County, through its Local Emergency Medical Services Agency (LEMSA) is responsible for the direct oversight of pre-hospital emergency and non-emergency medical care in the County of El Dorado; and

WHEREAS, County requires that Advanced Life Support (ALS) services provided by transporting and non-transporting units, and ALS Assessment Units, shall be performed in a manner that meets or exceeds the minimum acceptable standards as established by Health and Safety Code, Division 2.5; California Code of Regulations, Title 22, Division 9; the California Emergency Medical Services Authority; Ordinance No. 4991 and the Medical Control within the County of El Dorado, all incorporated by reference as if fully set forth herein; and

WHEREAS, County has established an application and permitting process for entities providing ALS Non-Transporting Units and ALS Assessment Units services; and

WHEREAS, County has determined that entities utilizing Emergency Medical Services personnel to provide ALS Non-Transporting Unit and ALS Assessment Unit services may do so after successfully completing the application and permitting process and entering into an agreement with the County, and payment of any fees established by the Board of Supervisors; and


WHEREAS, the Health and Human Services Agency, working with County Counsel and Risk Management, has developed an ALS Non-Transporting Unit / ALS Assessment Unit Permit Application/Agreement template, attached hereto as Exhibit A. The template is specific to services provided by a Permittee utilizing EMS personnel for the purpose of Non-Transporting Unit and Assessment Unit services provided at an Advanced Life Support level under the medical control of the LEMSAs.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado hereby authorizes the Director of the Health and Human Services Agency, or designee to execute future agreements using the attached "Advanced Life Support Non-Transporting Unit, Advanced Life Support Assessment Unit" Application and Agreement, for the purpose of providing first responder non-transport services at an ALS level, and further authorizes the Director of the Health and Human Services Agency, or designee, to perform any and all administrative responsibilities in relationship to said Agreement.
