VETERAN'S VETERANS SERVICE OFFICER

DEFINITION

Under general direction, plans, organizes, oversees, coordinates the programs, services, and reviews the work of staff performing routine to complex veterans' service activities, including assisting with short-and long-term planning, and overseeing the day-to-day activities of the Veteran's Service Office; coordinates assigned activities with other departments and outside agencies; provides expert professional assistance to County management staff the County Recorder/Clerk/Registrar of Voters/Director of Veterans Affairs on veterans' service matters; and performs related work duties as assigned.

DISTINGUISHING SUPERVISION RECEIVED AND EXERCISED

Receives general direction from the County Recorder/Clerk/Registrar of Voters/Director of Veterans Affairs. Exercises general direction and supervision over supervisory, professional, technical, and administrative support staff.

CLASS CHARACTERISTICS

The incumbent is responsible for accomplishing departmental goals and objectives, supervising staff, and directing day-to-day operations and activities of the Veteran's Service Office.

This is a supervisory classification responsible for planning, organizing, reviewing, and evaluating comprehensive Veteran's Service Office programs. Incumbents serve as a professional-level resource for organizational, managerial, and operational analyses and studies. Responsibilities include developing and implementing policies and procedures for assigned programs, budget administration and reporting, and program evaluation. Performance of the work requires the use of considerable independence, initiative, and discretion within established guidelines.

This class is distinguished from the County Recorder/Clerk/Registrar of Voters/Director of Veterans Affairs in that the latter provides overall management and administrative responsibility for all Veteran Affairs programs and activities.

EXAMPLES OF DUTIES/TYPICAL JOB FUNCTIONS (Illustrative Only)

- ~~Selects, trains, motivates, and directs department personnel; evaluates and reviews work for acceptability and conformance with department standards, including program and project priorities and performance evaluations; works with employees on performance issues; implements discipline and termination procedures; responds to staff questions and concerns.~~
- ~~Formulates and recommends policy to the County Recorder/Clerk/Registrar of Voters/Director of Veterans Affairs and the Board of Supervisors, and implements after adoption.~~
- ➤ ~~Analyzes the impact of legislation on departmental programs; identifies potential funding sources, and prepares budget estimates and projections.~~

Other Requirements:

~~Must possess a valid driver's license. Individuals who do not meet this requirement due to physical disability will be reviewed on a case-by case basis. In accordance with Section 970 of California Military and Veterans Code, incumbent must be a veteran.~~

Education and Experience:

~~Two~~Any combination of the required experience, education, and training that would provide the essential knowledge, skills, and abilities is qualifying.

Equivalent to a bachelor's degree from an accredited four-year college or university with major course work in business or public administration, behavioral sciences, or a related field., and four (4) years of experience in supervising veterans service activities at a level equivalent to the County's class of Senior Veterans Service Representative. The Veteran Services Officer must be a veteran of a branch of the United States Armed Forces, as defined in applicable sections of the State Military and Veteran's code.

Note: ~~The above qualifications are a typically accepted way~~ Licenses and Certifications:

- Possession of, or ability to obtain, a valid California Driver's License by time of appointment and a satisfactory driving record.
- Possession of, or ability to obtain, certification from the State of California Department of Veterans Affairs to present claims to the United States Department of Veterans Affairs in accordance with Section 970 of California Military and Veterans Code.

PHYSICAL DEMANDS

Must possess mobility to work in a standard office setting and use standard office equipment, including a computer; to operate a motor vehicle and to visit various County and meeting sites; vision to read printed materials and a computer screen; and hearing and speech to communicate in person, before groups, and over the telephone. This is primarily a sedentary office classification although standing and walking between work areas may be required ~~knowledge and skills.~~ Finger dexterity is needed to access, enter, and retrieve data using a computer keyboard, and to operate standard office equipment. Positions in this classification occasionally bend, stoop, kneel, reach, push and pull drawers open and closed to retrieve and file information. Employees must possess the ability to lift, carry, push, and pull materials and objects up to 25 pounds. Reasonable accommodations will be made for individuals on a case-by-case basis.

ENVIRONMENTAL CONDITIONS

Employees work in an office environment with moderate noise levels, controlled temperature conditions, and no direct exposure to hazardous physical substances. Employees may interact with members of the public or with staff under emotionally stressful conditions while interpreting and enforcing departmental policies and procedures.
