#### **Amendment I**

**THIS AMENDMENT to that AGREEMENT** made and entered into on June 26, 2007 by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and El Dorado Women's Center, a California Nonprofit Public Benefit Corporation qualified as a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, whose principal place of business is 1248 Broadway, Suite C, Placerville, CA 95667 (hereinafter referred to as "CONTRACTOR");

#### **WITNESSETH**

**WHEREAS**, County has determined that it is necessary to reduce the amount of compensation of this Agreement to more accurately reflect the share of expected revenue from collected marriage license fees; and

**WHEREAS**, Contractor has represented to County that it is specially trained, experienced, expert and competent to perform the special services required under the Agreement as modified by this Amendment and County has determined to rely upon such representations; and

**WHEREAS**, it is the intent of the parties hereto that such services be in conformity with all applicable federal, state and local laws; and

**WHEREAS**, County has determined that the provisions of such services provided by Contractor are in the public's best interest, are more economically and feasibly performed by outside independent Contractors as well as authorized by El Dorado County Charter, Section 210 (b) (6) and/or Government Code 31000;

**NOW, THEREFORE,** County and Contractor mutually agree as follows:

Page 5, Referenced Contract Provisions, shall be amended as follows:
