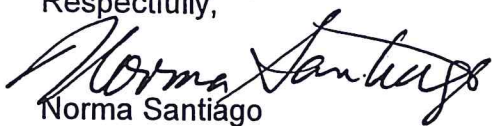
Dear Ms. Hanzioaka:
