AGREEMENT FOR SERVICES #271-S1310 (FENIX #525)
AMENDMENT III

This Amendment III to that Agreement for Services #271-S1310, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Eric S. Hill, doing business as Hilltop Tree Service, a sole proprietorship duly qualified to conduct business in the State of California, whose principal place of business is 2561 Hoot Owl Ravine Road, Placerville, California 95667 (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, Contractor has been engaged by County to provide certified arborist services and reports, and tree and brush cutting services for matters of public safety, in accordance with Agreement for Services #271-S1310 dated November 5, 2012, Amendment I dated January 6, 2014, and Amendment II dated September 29, 2015, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the total amount of said Agreement by \$50,000.00 for a new total not-to-exceed amount of \$212,196.00 hereby amending **ARTICLE III – Compensation for Services**; and

WHEREAS, the parties hereto have mutually agreed to amend **ARTICLE XVIII – Notice to Parties** and **ARTICLE XXXI – Contract Administrator**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #271-S1310 shall be amended a Third time as follows:

ARTICLE III

Compensation for Services: is hereby amended to increase the total not-to-exceed amount of the Agreement by \$50,000.00 for a new total not-to-exceed amount of \$212,196.00, inclusive of all cost and expenses.

ARTICLE XVIII is hereby amended to read as follows:

ARTICLE XXXI is hereby amended to read as follows:

Contract Administrator: The County Officer or employee with responsibility for administering this Agreement is Ashley Wells, Department Analyst, Chief Administrative Office, Procurement and Contracts Division, or successor.

Except as herein amended, all other parts and sections of that Agreement #271-S1310 shall remain unchanged and in full force and effect.
