FIRST AMENDMENT TO AGREEMENT FOR SERVICES #6606

THIS FIRST AMENDMENT to that Agreement for Services #6606 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Sonitrol of Sacramento LLC, a limited liability company duly qualified to conduct business in the State of California, whose principal place of business is 1334 Blue Oaks Boulevard, Roseville, California 95678 (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide routine monitoring, as-needed maintenance and repair services, and emergency repair services for the security systems that regulate, restrict, and monitor access (access control systems) to various County-operated facilities for its Chief Administrative Office, Facilities Division pursuant to Agreement for Services #6606, dated June 30, 2022, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to update the County notice recipient information, amending **ARTICLE XXIV, Notice to Parties**;

WHEREAS, the parties hereto desire to amend the Agreement to update County's Contract Administrator, amending **ARTICLE XL, Contract Administrator**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #6606 on the following terms and conditions:

- I. ARTICLE XXIV, Notice to Parties**, of the Agreement is amended in its entirety to read as follows:

- II. **ARTICLE XL, Contract Administrator**, of the Agreement is amended in its entirety to read as follows:

ARTICLE XL

Contract Administrator: The County Officer or employee with responsibility for administering this Agreement is Charles Harrell, Facilities Division Manager, Chief Administrative Office, or successor.

Except as herein amended, all other parts and sections of Agreement for Services #6606 shall remain unchanged and in full force and effect.
